1. BACKGROUND:

Oil & Gas Development Company Limited (OGDCL), Pakistan is engaged in procurement of different API sizes screens to be used at shale shakers & mud cleaners (Derrick FLC-500 series) installed at rigs. Scope of work (S.o.W) for this inspection job is given below.

2. MANUFACTURER/ SUPPLIER SCOPE

Supplier of the screens will intimate two weeks in advance (before packing for shipment) for the said inspection and will extend full cooperation to third party inspectors. All arrangements for TPI will be supplier's responsibility. Skilled and un-skilled manpower required for inspection will be provided by the supplier. All relevant QA/QC certificates and test reports in original will made available by the supplier/ manufacturer to inspector for examination and a copy of the same to be provided to inspector for record.

3. SCOPE OF WORK.

Third party inspection agency will carry out the required inspection according to the scope of work including but not limited to the following terms of reference.

- 3.1 Third Party Inspection Agency (TPIA) will certify that the screens to be supplied by the supplier are:
 - 3.1.1 As per technical specifications, quantity, part numbers and capacity/size given in the purchase order.

- Newly manufactured (within past 18 months of the date of purchase order), 3.1.2 unused and free from defects in material and workmanship.
