TERMS & CONDITIONS FOR THE BIDDERS

- 1. The spares mentioned in this tender are required for VARCO TDS (Top Drive System) Model 11-SA installed at OGDCL rigs N-5 & N-6. Part numbers mentioned in this tender enquiry are as per Original Equipment Manufacturer (OEM) parts manual. In case, any bidder offers the required parts with replaced part numbers, it must be clearly mentioned in the technical proposal that the required part numbers have been replaced/superseded with the quoted new part numbers.
- 2. For bidder other than the manufacturer, bidder to provide authority letter of the quoted manufacturer or their authorized dealer / distributor in original with technical bid against this tender enquiry (scanned copy will not be accepted). In case, bidder offers required parts from authorized dealer/distributor, a copy of authority letter issued by the quoted manufacturer in favor of the dealer/ distributor will also be required.
- 3. In case any bidder offers equivalent parts manufactured by manufacturers other than OEM (M/s NOV), following will be required;
 - i. The manufacturer shall have manufacturing experience for last fifteen (15) years of mentioned parts. In this regard, Business License issued in favor of the manufacturer by the chamber of commerce or any other regulatory authority of the manufacturer's country must be provided with the technical bid. The Business license (or any other legal certificate) shall reflect date of business establishment, company name and company business brief in English language.
 - ii. Bidder to provide with the technical bid the manufacturer's company profile and sale record for last five (05) years for same type of items by mentioning client names, addresses, e-mails and phone/fax numbers. OGDCL reserves the right to re-confirm the authenticity of provided sale record from the clients.
 - iii. Bidder to provide with the technical bid copies of minimum five un-priced materialized sale contracts/ purchase orders and supporting invoices for supplying adequate quantities (comparable to quantities in this OGDCL tender) of similar items to different international drilling contractors or drilling companies other than and outside the manufacturer's own country.
 - iv. Bidder to provide with the technical bid the satisfactory performance certificates/ statements from at least three end users of the above contracts, stating that the parts manufactured by the quoted manufacturer (name to be mentioned) and supplied against contracts/ purchase orders (contracts reference to be mentioned) have been utilized in repair/ major overhauling of VARCO Top Drive System (TDS) Model 11-SA and

their performance found satisfactory. The sale contracts & certificates (mentioned above) shall bear valid addresses (postal/e-mail) and phone/ Fax numbers of the end users (customers). OGDCL reserves the right to re-confirm the authenticity of provided contracts/ purchase orders and certificates from manufacturer and end users.

- v. Bidder to provide with the technical bid, a certificate issued by the quoted manufacturer that the offered parts are 100% EQUIVALENT to the parts mentioned in the Schedule of Requirement (SOR) and that no additional parts/alteration/modification will be required by the end user during utilization in the VARCO TDS 11 SA.
- 4. The offered "Wash Pipe assemblies" and their spares to be covered by the OEM warranty/Guarantee against miss-fitness & bad performance at the time of use for a period of one year from the date of installation or 18 months from the date of shipment.
- 5. All bidders to confirm that offered parts will be supplied as newly manufactured, unused and free from any defect of material and workmanship. Any defective or wrong item shall be immediately replaced by the bidder/ supplier with correct part at no additional cost to OGDCL.
- 6. All bidders to mention in their commercial proposals the description, quantity, unit price (FOB), unit price (CFR Karachi) and extended price as per schedule of requirement.
- 7. Delivery period will be 90 days after establishment of Letter of Credit.
- 8. OGDCL may increase or decrease the quantity of the required spares as per its own requirement.
- 9. Parts must be packed in a compact manner to ensure safe handling and transportation during shipment.
