TERMS & CONDITIONS FOR BIDDERS

- 1. The roller chains in this tender are required for the equipment installed at OGDCL Rigs N-1, N-2, N-3, N-4 & N-55.
- 2. Bids from oilfield roller chain manufacturers will be accepted only. Moreover, the bidders (manufacturers) to have
 - 4.1 Manufacturing experience of fifteen (15) years (Minimum)
 - 4.2 API 7F certification for the last fifteen (15) consecutive years (Minimum)
 - 4.3 Active (currently valid) API 7F certification.

Copies of API certificates in this regard must be provided with the technical proposal. The API 7F certificates should clearly reflect manufacturing of the oilfield roller chains.

- 3. All bidders are to provide, with the technical proposal, a sale record/list of supplies for the last Fifteen (15) years showing sale of the offered or similar oil field roller chain(s). The sale record should contain details of sold oilfield roller chain, name of customer, country & contact details e.g. postal and e-mail address and Phone/ Fax numbers.
- 4. All bidders to provide, with the technical proposal, copies of at least five un-priced sale contracts/ purchase orders showing supply of adequate quantities of the offered chains (comparable to quantities in this OGDCL tender) to international oil and gas drilling contractors/ drilling
 - companies other than and outside the bidder's own country.
- 5. In case any bidder offers the oil field roller chains in this tender with replaced/ superseded part numbers, it must be clearly mentioned in the technical proposal that the required part number has been replaced/ superseded with the quoted new part number and that all the new part numbers are 100% exact replacement to the required part numbers in terms of design, compatibility and function and that no alteration/ modification/ machining etc. will be required for utilization/ installation by the end user.
- 6. Oil Field Roller Chains (Cottered Type) manufactured by M/s (Rexnord (Link Belt), Diamond, Timken, Renold, Drives-USA) and manufactured in USA, Canada, Japan or any European country will be accepted only due to criticality of the main equipment and associated operation.
- 7. All bidders to confirm that oil field roller chains will be supplied as newly manufactured, unused and free from any defect of material and workmanship. Any defective or wrong item shall be immediately replaced by the bidder/ supplier with correct part at no additional cost to OGDCL whatsoever.
- 8. The oil field roller chains supplied must be covered by the manufacturer's warranty for 18 months from the date of shipment or one year from the date of installation/ utilization by the end user. Bidder/ supplier will be responsible for immediate replacement of any /all

items at the bidder's/ supplier's own cost if found not compatible to tender specifications, design, dimensions and function/performance (as confirmed by the bidder in technical bid or during bid evaluation) whether during inspection or during use at rig in the warranty period. OGDCL will not pay any charges for such replacements whatsoever.

- All bidders to mention in their commercial proposals the description, quantity, unit price 9. (FOB), unit price (CFR Karachi) and extended price as per schedule of requirement.
- 10. OGDCL tender documents, Tech/Financial Bids submitted by the bidder and subsequent clarifications/confirmations (if any) will be integral part of the subsequent purchase order.
- 11. Delivery period shall be 120 days after establishment of Letter of Credit.
- 12. Certificate of origin and compliance to be provided to OGDCL before delivery/ shipment of the material.
