TERMS AND CONDITIONS FOR SUPPLY:

1. Manufacturer of Pumps should have 5 years of manufacturing experience.
2. Technical brochure of pump to be provided with Technical bid.
3. Operational & Maintenance manual must be provided with the supply of pumps.
4. Detail of working fluid is as under;
 - a. For pump at Sr.# 1: Lube oil @ 30 °F
 - b. For pump at Sr.# 2: Monoethylene Glycol / Triethylene Glycol @ 30 °F
5. Delivery period for material is 12 weeks from the date of issuance of Purchase order.
6. Minor variation ($\pm 5\%$) in quoted flow and head will be acceptable.
7. Bidder must provide documentary evidences for the supply of pumps, besides unpriced copy of contract, purchase order with name and full contact details to be provided in technical bid.
8. List of 02 years' spare parts to be attached with bid (with cost of each spare part). The cost of 02 years' spare parts will not be included in financial evaluation. OGDCL will select the spare parts at its own choice.
9. The material will be delivered at Chanda Plant, the delivery charges to Chanda Plant City Kohat, to be borne by the supplier / bidder.
10. Guarantee / warrantee for the equipment for a period of 01 years after being taken into service or 18 months after shipment, whichever completes earlier.
11. Payment will be released when successful inspection of material at site is completed. OGDCL has the right to reject whole or part of material if inspection results found unsatisfactory.
