**TERMS & CONDITIONS FOR BIDDERS**

- 1- The required vertical pumps will be used as Cellar Pumps at OGDCL drilling rigs. The electric motor and other electrics must be explosion proof classified for use in Class-1, Division-1, Group C and D hazardous area.
- 2- Manufacturer of the offered pumps must have at least 15 years experience in manufacturing of these pumps. Bidder will submit the following documents as documentary proof along with the technical bid:
  - 2.1- Company profile of the bidder and manufacturer showing business background and work history.
  - 2.2- Verifiable sale record for the last five (5) years with details of clients (name, country, contract number, postal and e-mail address, phone/ fax numbers etc.)
  - 2.3- Copies of at least four (04 No.) unpriced materialized sale contracts showing supply of the offered pumps to international clients other than and outside the manufacturer's own country.
  - 2.4- Copies of satisfactory performance reports (of the offered pumps) from any two end users against the sale contracts provided vide Sr. No. 2.3 above.
- 3- If bidder is not manufacturer, an authority letter from the manufacturer or their authorized dealer/ distributor in favor of the bidder must be provided along with the technical proposal. Such authority letter must have the following features.
  - 3.1- Printed on the letterhead of OEM or authorized dealer/distributor of OEM.
  - 3.2- Submitted with the technical bid in original.
  - 3.3- Duly signed and stamped by the OEM or authorized dealer/distributor of OEM as the case may be.
  - 3.4- Bearing OGDCL tender enquiry number.
  - 3.5- Stating that OEM/ OEM authorized distributor (name to be mentioned) has authorized the bidder (name to be mentioned) to offer the Vertical Pumps (Description/Model to be mentioned) against mentioned OGDCL tender enquiry and that genuine, new and unused Vertical Pumps will be supplied free from any defect in material and workmanship.
- 4- Bidder to offer the required Vertical Pumps with complete description, part number and quantity. Moreover Vertical Pumps to be supplied complete in all respect.
- 5- Adequate and relevant manufacture literature for the offered Vertical Pumps must be provided with the technical bid to facilitate technical evaluation of the proposal.
- 6- Bidder to mention in financial bid the description, quantity, unit price (FOB), unit price (CFR Karachi by sea) & extended price.
- 7- The design of the Vertical pumps should be as per picture attached (Page No.2) and the offered pump must be complete with metallic suction strainer, suction and discharge piping etc.



- 8- The offered Vertical Pumps to be covered by the manufacturer warranty/ guarantee for a period of one year from date of installation or 18 months from the date of shipment. Bidder/ Supplier will immediately replace any or all defective units free of cost during the warranty period at no additional cost to OGDCL.
  - 9- Quantity of the required vertical pump may be increased or decreased as per OGDCL requirement.
  - 10- Delivery period: 120 days from the date of establishment of LC.
- NOTE:** The above mentioned terms and conditions are integral part of the tender enquiry.

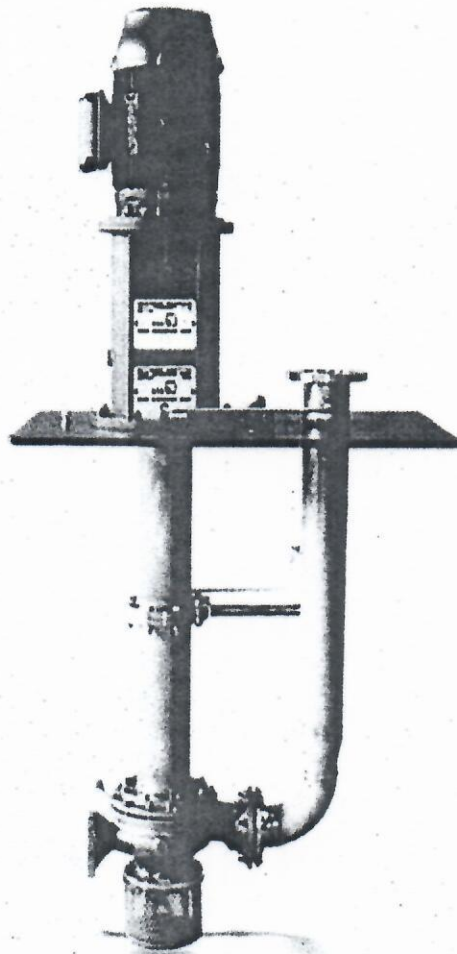


Figure – 35 HP, 3"X4" Vertical Pump (Cellar Pump)
