

PROCUREMENT OF SPARES OF M/S NL-SHAFFER (NOV) BOP

GENERAL TERMS & CONDITIONS:

1. All the quoted spare parts must have the same part numbers as per SOR. In case of different part numbers quoted, OEM (M/s NL-SHAFFER - NOV) to clarify.
 2. All the quoted spares parts must be brand new & un-used. Manufacturing date of each quoted part to be provided.
 3. Genuine parts of OEM i.e. M/s NL-SHAFFER - NOV, USA are to be quoted from OEM or its authorized distributors / dealers. Valid Authorized distributor letter to be submitted with the Bid.
 4. Authority letter in original from the manufacturer to bidder and from bidder to local agent for offered spares parts with tender enquiry number must be furnished with the technical offer. The authority letter must be on company letter head, showing name and contact details (E-mail & Fax number) of the signing authority.
 5. In case Bidder/Manufacturer quote equivalent spare parts with different part numbers, following additional documents to be provided with the bid.
 - 5.1. The Manufacturer of BOP spares must have consecutive and last 03 years valid API 16A for manufacturing of spares of BOP.
 - 5.2. The manufacturer must have minimum fifteen (15) year's experience in manufacturing of BOP spares. In this regard, bidder should provide comprehensive supply record of BOP spares for last fifteen years.
 - 5.3. Manufacturer/authorized dealer/authorized distributor of the manufacturer have to provide Three (03) numbers satisfactory performance certificates or Customer satisfactory survey in favor of quoted Manufacturer for BOP spares issued by 03 (Three) different renowned international E&P companies like Shell, BP, MOL or equivalent E&P company / Drilling Contractors like Slb, Exalo etc working in other than manufacturer's own country. To ascertain the equivalency stature of E&P company / drilling contractor other than mentioned above will be OGDCL sole discretion.

- 5.4. Copies of 05 unpriced purchase orders showing supply of BOP spares to renowned companies mentioned at 5.3 to be furnished with the bid.
 - 5.5. A certificate from the quoted manufacturer on its own letterhead clearly stating that the offered equivalent parts are 100% compatible (in design, dimensions and function/performance) with M/s Control Flow BOP without any alteration, fabrication and performance issues.
 6. Confirmation from OEM that quoted Elastomers/Rubber elements & seals will be oil base Mud Resistant & having temperature rating upto 120 °C.
 7. Part number of spare parts must be mentioned on spare parts as per accepted Purchase Order.
 8. The Manufacturer will be required to furnish mill inspection certificate for quoted spare parts with shipping documents. Confirmation to this effect must be provided in the offer.
 9. Warranty/Guarantee letter for offered spare parts to be provided for a period of 18 months from date of shipment.
 10. Manufacturer of the spare parts to provide Material test certificate (MTC) / Certificate of conformance (COC) for quoted spare parts.
 11. Delivery required: - Within five (05) months after establishment of letter of credit (LC) on C&F Karachi by sea basis.
 12. Bidder to provide soft copy of the bid as well.
