- 1.1 Bids shall be received at the above address on or before the time and date mentioned against tender enquiry (at least half hour earlier to bid opening). Bidder(s) or their authorized representative(s) are encouraged to attend the tender opening meeting on the specified date and time.
 - 1.2 Material/ parts are to be delivered at OGDCL Rig N-2. Current location of the rig is mentioned above, however, if the rig location is changed at the time of material delivery, will be shared with supplier accordingly.
2. Bids must be submitted under single envelope bidding system. The envelope must contain techno-commercial proposal.
 3. The quoted material (channel/I-beam/angle iron/grating/sheet) must be made up of ASTM A-36 grade and seamless pipe must be made up of ASTM A53 grade B.
 4. The material must be provided in the following measurements;

5. Price(s) to be quoted in **Pak Rupees (PKR)** and must be firm (inclusive of GST, other taxes, and duties).
6. Bidders are required to submit a bid bond of PKR 50,000/- (Rupees Fifty Thousand only) in favor of Operation Manager, OGDCL Rig N-2, Tando Allahyar, Sindh at the time of bid submission. Any bid without bid bond will be rejected out rightly.

7. If any clarification is required, it may be obtained from the office of Operation Manager, I/c Rig Maintenance, OGDCL Rig N-2.
8. Bids will be evaluated on full consignment basis.
9. All bidders to confirm that the offered material shall be supplied as newly manufactured (with the date of manufacture not later than one (01) year, unused and free from any defect of material and workmanship. Any defective channel/angle iron/pipe/sheet/grating/I-beam shall be immediately replaced by the bidder / supplier with new channel/angle iron/pipe/sheet/grating/I-beam at no additional cost to OGDCL whatsoever.
10. Delivery must be made within 10 days after issuance of purchase order. The material to be delivered at OGDCL Rig N-2. Current location of OGDCL Rig N-2 is mentioned above (Serial No.1), however, any change in location (if occurred) at the time of delivery, will be shared with supplier.
11. Payment shall be made after delivery, inspection and acceptance by OGDCL against original invoice with annexure – C and inspection report duly verified/ signed and stamped by OGDCL Rig N-2 Management. Payment will be made to the supplier through Accounts Payable Section-Fields at OGDCL Head Office, Islamabad.
12. OGDCL reserves the right to annul the bidding process at any time prior to issuance of purchase order/ award of contract.
13. Quantity of the required spare parts may be increased or decreased as per OGDCL requirement.
