## TERMS AND CONDITIONS FOR BIDS SUBMISION AND JOB EXECUTION:

(PST stands for Provincial Sales Tax, ICT stands for Islamabad Capital Territory Sales Tax and PKR stands for Pak Rupees)

- 1. The rate and amount should be inclusive of all applicable taxes excluding kPST / ICT. The rate and amount of PST / ICT Sale Tax will be mentioned separately in the above referred relevant row / column.
- 2. Bidders must submit complete tender documents as available on website and having duly stamped and signed at the time of submission of bid otherwise OGDCL reserves the right to reject the bid.
- 3. The contractor being registered with respective revenue authority is entitled to charge applicable sales tax over and above its bid price (excluding sales tax) and will be responsible for the payment of such sales tax to the respective revenue authority as per prevailing laws. OGDCL shall reimburse the amount of sales tax to the concerned contractor based on valid payment documents of respective revenue authority.
- 4. OGDCL shall withhold applicable income tax / PST / ICT as per prevailing withholding rules.
- 5. Accommodation to the workers and supervisor of the contractor will be the whole responsibilities of the contractor. No Accommodation, pick and drop will be provided by OGDCL.
- All tools and accessories including utility water for construction will be the responsibilities of contractor.
- All HSEQ Policy of OGDCL will be follow in true spirit and PTW will be follow during job execution
  and in case of any violation or any damage of materials /manpower will be the responsibilities of
  contractor.
- 8. The unit rates and prices in the Schedule of Prices shall be quoted by the bidder in the currency PAK. Rupees
- 9. The material is required to be delivered at Togh Gas Field.

- 10. Each bidder shall furnish, as part of his bid, at the option of the bidder, a Bid Security in the amount stipulated in Bidding Data in PKR in the form of Bank Draft/Call Deposit Pay order or Bank Guarantees per format provided) in favor of Employer valid for a period up to 28 days beyond the bid validity date.
- 11. Bids must be received by the Employer at the address/provided in Bidding Data not later than the time and date as mentioned in the WEB advertisement.
- 12. The Employer will award the Contract to the bidder whose bid has been determined to be substantially responsive to the Bidding Documents and who has offered the lowest evaluated Bid Price, provided that such bidder has been determined to be qualified to satisfactory perform the Contract in accordance with the OGDCL standard demand.
- 13. Payment will be made through cross cheque after completion of the job activities in all respect. Including housekeeping.
- 14. Period of the bid validity 100 calendar days. The bid validity period may be extended by the bidder in case of expiry of the bid validity, at the request of the employer. If the contractor will not extend the bid validity, then his bid security may be released without any forfeiture.
- 15. The Bid is valid till required period, the Bid prices are firm during currency of contract.
- 16. The successful bidder is required to deliver complete scope of the project within 120 days.
- 17. The evaluation of the bids shall be done on the price of complete scope of project (inclusive of taxes). The bidders are required to bid for complete scope of project, otherwise their bids shall be rejected.
- 18. Late delivery charges shall be applicable if the scope of material / services is not delivered within the project completion period, as per OGDCL's standard terms and conditions as described in the Master Set of Tender Documents (Local procurement cases), uploaded on the company's website.
- 19. Unless otherwise stipulated in the Contract Data, the rates and prices entered by the bidder shall not be subject to adjustment during the performance of the Contract. All duties, taxes and other levies payable by the Contractor shall be included in the rates and prices. The whole cost of complying with the provisions of the Contract shall be included in the items provided in the Schedule of Prices, and where no items are provided, the cost shall be deemed to be distributed among the rates and prices entered for the related items of the Works and no separate payment will be made for those items.
