TERMS AND CONDITIONS FOR SUPPLY

- 1. The supplier of pipes and fittings will have minimum of 5 years of past experience in the supply of same items.
- 2. The supplier must submit Performance Certificate from 03 No.s of Oil & Gas/ Petrochemical Clients for the satisfactory supply & performance of pipes and fittings.
- 3. Testing certificates/ Mill certificates have to be provided by the supplier otherwise the material will be rejected during inspection.
- 4. The manufacturing of pipes should be as per ASME B36.10/API codes and standards.
- 5. OEM certificate along with MTC's for pipes material to be submitted that should clearly mention material details as per ASME standards.
- 6. Delivery period for material is 2-3 weeks from the date of issuance of Purchase order.
- 7. Single stage, single envelop bidding will take place along with Item wise evaluation criterion for the bids.
- 8. The variation in quantity at the time of order placement will not change the unit cost of material.
- 9. The material will be delivered at Dakhni Gas Plant and the delivery charges to Dakhni gas processing plant are to be borne by the supplier / bidder.
- 10. The bidder is requested to quote per meter rate against each pipe and the committee will evaluate each pipe size separately and quantity of each may increase or decrease in order to adjust the total amount within web tender limit.
- 11. The tender committee reserves the right to increase or decrease the quantities or may cancel any or all items shown in the SOR without assigning any reason thereof.
- 12. All the pipes delivered at site will be inspected at site, and after necessary inspection of material and acceptance the invoices will be processed accordingly.
- 13. Payment will be made through cross Cheque and payment will only be released once successful inspection of material at site is completed. OGDCL has the right to reject whole or part of supplied pipes if inspection results found unsatisfactory.
- 14. Any damaged pipe material found during inspection will have to be replaced by the supplier without any extra charges.
- 15. All carbon steel pipes mentioned in the SOR shall be NACE compliant and have documented evidence of.
