4. **Evaluation Criteria:** MAIN EQUIPMENT WISE ON CFR BY SEA KARACHI BASIS.
5. Bidders to quote unit price of each quoted item in financial bid only. Cost of two years recommended and optional spares will not be the part of financial evaluation. Also see the clause 9 of Technical Terms of Reference of SOR
6. **Delivery Period:** 4 Months
7. **Foreign Procurement Payment Terms (Competitive Bidding)**

Following payments methods will be applied for Competitive Bidding/Press Tender;

i. Tender value less than or equal to US\$ 200,000:

Payment to the Contractor/ bidder in foreign currency shall be made by establishing in favor of the Contractor an irrevocable Letter of Credit (hereinafter called the L/C). 70 % Payment (s) under the L/C will be made for the FOB/ CFR / CPT (as the case may be) price of material of each shipment upon submission of the shipping documents. Balance 30% Payment will be released after receipt, inspection and acceptance of material.

TERMS OF REFERENCES FOR PROCUREMENT OF DIESEL WELDING PLANT
FOR NASHPA PLANT

1. All the standard accessories and optional accessories must be mentioned in the technical bid.
2. The manufacturer of welding machine should be well reputed, European / American / Japanese based like Miller, Lincoln, Esab, Crompton or equivalent.
3. The Diesel welding machine should be in canopy, easily portable.
4. Welding Machine should be accompanied with welding cable (15-20 mtr), Electrode holder, Earthing cable (15-20 mtr), Ignition switch, Resistors and Wheel trolley with steerable front wheels.
5. Technical literature for welding machine and diesel engine should be provided with Technical Bid.
6. Operational manual should also be provided with supply of Diesel Welding machine.
7. The bidder should have established after sales services facilities within Pakistan.
8. The bidder should offer guarantee of 01 year operational / 18 months after shipment, whichever comes earlier.
9. List of 02 years spare parts to be attached with bid (with cost of each spare part). The cost of 02 years spare parts & optional spare parts will not be included in financial evaluation. OGDCL will select the spare parts at its own choice.
10. Manufacturer should have 10 years experience of manufacturing / supply of welding plant.
11. Reference list for the supply of welding plants internationally, to be placed in Technical Bid.
12. Delivery period is 04 months after issuance of L/C.
