Note:

- 1. Bid bond:**-Pursuant to tender clause # 2.2, 11.4, 13 & 35.3.2, bid(s) must be accompanied by an upfront bid bond in the form of pay order/ demand draft or bank guarantee issued by scheduled bank of Pakistan or a branch of foreign bank operating in Pakistan, for an amount of **US\$ 8,500/- (US\$ Eight thousand five hundred only)** or equivalent Pak Rupees, with technical bid and valid for 150 days from the date of opening of the bids. The bank guarantee must be issued in accordance with the format as per Annexure-C of the tender documents.
- 2. Shipment from ACU member Countries:** In case of shipment from ACU member countries, the LC beneficiary should be of that particular country from where the consignment is being shipped.
- 3. Terms and conditions:**-Bidders are advised to carefully read all the terms and conditions of the Tender Document available at OGDCL web site in the master tender document.
- 4. Summary rejection criteria:** - The summary rejection criteria at clause 35 of the tender document may also be examined carefully. Any bid not meeting the criteria spelled in the clause # 35 shall be summarily rejected without any right of appeal. The detailed tender document is available on OGDCL website as "Master set of tender document-Foreign".
- 5. Payment Terms:** Clause No: 4 of Section-III (Part-B) i.e. Conditions of Contract "Special" of Tender Document has been amended and following will be the payments methods.
 - i. **Tender value less than or equal to US\$ 200,000:**-Payment to the Contractor/ bidder in foreign currency shall be made by establishing in favor of the Contractor an irrevocable Letter of Credit (hereinafter called the L/C). 70 % Payment (s) under the L/C will be made for the FOB/ CFR / CPT (as the case may be) price of material of each shipment upon submission of the shipping documents. Balance 30% Payment will be released after receipt, inspection and acceptance of material.
 - ii. **Tender value more than US\$ 200,000:** Payment to the Contractor/ bidder in foreign currency shall be made by establishing in favor of the Contractor an irrevocable Letter of Credit (hereinafter called the L/C). 80 % Payment (s) under the L/C will be made for the FOB/ CFR / CPT (as the case may be) price of material of each shipment upon submission of the shipping documents. Balance 20% Payment will be released after receipt, inspection (in addition of pre-shipment inspection) and acceptance of material.

1. The spares are required for major overhauling of mud pump, model 12P-160 (OEM M/s National Oil Well, USA) installed at OGDCL land drilling rig. Bidder has to notify in advance if any of the OGDCL demanded part(s) is/are not appropriate - superseded and/or discontinued- and suggest for correct part(s).
2. If the bidder is not OEM of offered part(s), a hard copy of authority letter on letterhead of OEM/ OEM authorized distributor in original must be provided with the bid stating that OEM/ OEM authorized distributor has authorized the bidder to offer the parts against this OGDCL tender enquiry. Scanned authority letter or its photocopy will not be accepted.
3. For all offered bearings, bidder to mention in technical bid, bearing manufacturer name, part number & country of origin. Bidder to further provide bearings technical literature, specification, drawing, dimensions and standards of manufacturing. The bearing manufacturer shall have minimum twenty (25) year experience of manufacturing such heavy duty bearing. Documentary proof in this regard to be provided along with the bid.
4. Bidder to provide along with the bid, a certificate from manufacturer confirming that all the offered items to be supplied are new, not re-manufactured and un-used. Manufacturer part number shall be mentioned on packing or engraved on each item.
5. Bidder will be responsible for immediate replacement of any /all items, if found, not compatible with the mud pump without any additional charges to OGDCL.
6. Bidder to mention in financial bid, description, quantity, unit price (FOB), unit price (CPT Karachi) & extended price. OGDCL may increase or decrease quantity as per its own requirement at the time of placing order.
7. Bidder to provide 12 months performance warranty for offered items from date of installation or 18 month from date of shipment.
8. Bidder to submit all the documents – bid, catalogue & certificates etc- in English language.
9. Pre-shipment inspection of the consignment will be carried out by third party inspection agency at the manufacturer premises. Third party inspection agency will be selected by OGDCL. Scope of work for pre-shipment third party inspection is attached as "Annexure-1". Supplier has to intimate at least two weeks in advance (before packing for shipment) for the said inspection and will extend full cooperation to third party inspectors. All arrangements for third party inspection will be supplier's responsibility. Skilled and un-skilled manpower required for inspection will be provided by the supplier. All relevant QA/QC certificates and test reports in original will made available by the supplier/ manufacturer to inspector for examination and a copy of the same to be provided to inspector for record.
