TERMS & CONDITIONS FOR BIDDERS

1. The Assembly mentioned in this tender is required for Derrick USA ,500 series Shale shakers & Mud Cleaners installed at all OGDCL rigs. Part number mentioned in this tender enquiry is as per OEM parts manual. In case any bidder offers the required part with replaced part number, it must be clearly mentioned in the technical proposal that the required part number has been replaced/ superseded with the quoted new part number and that the new part number is 100% exact replacement to the required part number.
2. For bidders other than OEM (M/s Derrick), authority letter of manufacturer or authorized dealer/ distributor of manufacturer in original with technical bid against this tender enquiry must be provided. Scanned copy or photocopy will not be accepted.
3. All bidders to provide, with the technical proposal, a sale record/ list of supplies for the last five (5) years showing sale of the offered or similar parts of shale shakers/mud cleaners. The sale record should contain details of sold parts of shale shakers/ mud cleaners, names of customers, country & contact details e.g. postal and e-mail addresses and Phone/ Fax numbers.
4. Bidder to supply the required items from a manufacturer having minimum ten (10) year manufacturing experience of solids control equipment and their spares.
5. The offered "Float Mount Assemblies" to be covered by the manufacturer's warranty/guarantee against miss-fitness & bad performance at the time of use for a period of one year from the date of installation or 18 months from the date of shipment.
6. All manufacturers to provide with the technical proposal, copies of at least three un-priced sale contracts/ purchase orders for supplying adequate quantities (comparable to quantities in this OGDCL tender) of similar parts of shale shakers/ mud cleaners to international oil and gas drilling contractors/ drilling companies other than and outside the bidder's own country.
7. All bidders to confirm that offered parts will be supplied as newly manufactured, unused and free from any defect of material and workmanship. Any defective or wrong item shall be immediately replaced by the bidder/ supplier with correct part at no additional cost to OGDCL.
8. All bidders to mention in their commercial proposals the description, quantity, unit price (FOB), unit price (CFR Karachi) and extended price as per schedule of requirement.
9. Delivery period will be within 90 days after establishment of Letter of Credit.
10. OGDCL may increase or decrease the quantity of the required "Float Mount Assemblies" as per its own requirement.
11. Parts must be packed in a compact manner to ensure safe handling and transportation during shipment.
