GENERAL TERMS & CONDITIONS

1. The manufacturer of elevators (Casing) links must have an approval of API specs 8C for the last Fifteen (15) years as elevator links manufacturer and must have active 8C certification for manufacturing elevator links with PSL level -2. In this regard latest & consecutive Fifteen years back 8C certificates of quoted manufacturer must be submitted with the technical offer or authentic proof from API official website for the same to be submitted with the technical offer.
2. Manufacturer should confirm that all elevator links will be manufactured from AISI 4145 H modified alloy steel and heat treated to hardness 285-341 BHN impact test value 40 lb/ft, body to be ultrasonically inspected,. All other physical properties in accordance with API specs-8C.
3. The elevator links must be brand new & un-used. Confirmation to this effect is required in the technical offer.
4. The successful bidder will be required to furnish mill inspection certificate for elevator links with shipping documents. Confirmation to this effect must be provided in the technical offer.
5. Original letter from the manufacturer(s) covering Warranty/Guarantee for offered elevator links for a period of 1-1/2 years from date of shipment with tender enquiry number must be furnished with the technical offer.
6. Authority letters in original from the manufacturer(s) to bidder and from bidder to local agent for offered elevator links with tender enquiry number must be furnished with the technical offer. The authority letter must be on company letter head, showing the name and contact details (E-mail & fax number) of the signing authority.
7. Original Brochure or brochure on CD format of the manufacturer(s) containing technical literature/specs sheets specifying physical/performance properties of quoted elevator links must be submitted with the technical offer.
8. The manufacturer should have minimum Fifteen years (15) years' experience in the manufacturing of elevator links and have supplied elevator links each year during last 10 years to the major international E & P & drilling contractor companies like Saudi Aramco, PDO, KOC, Shell, BP, Total, ENI, MOL, OMV, Schlumberger, Weatherford, Exalo etc or equivalent E & P and drilling contractor companies. In this regard bidder(s)/ manufacturer should provide last 10 (ten) years comprehensive detailed supply record other than manufacturer's own country containing detail of offered and similar elevator links, quantity, name of customers should be submitted with the technical offer. In case Manufacturer has not already supplied elevator links to OGDCL then unpriced copies of atleast 10 different purchase order for offered & similar elevator links sold in other than manufacturers own country should also be submitted with technical bid. The supply record must be on the company letterhead and should indicate the Name & Designation of the signing authority along with his complete contact details phone & fax numbers and his official email address. (Documentary evidence to prove the equivalent stature of E & P company/ Drilling contractors other than specified above will be required alongwith technical bid, to ascertain the equivalency of E & P company/ Drilling contractors other than specified above will be OGDCL sole discretion).



9. If manufacturer has not already supplied elevator links to OGDCL then certificates of satisfactory performance of elevators issued by authorized official(s) of at least 3 (Three) different renowned international E&P companies (belonging to other than manufacturer's own country) like Saudi Aramco, PDO, KOC, Shell, BP, Total, ENI, MOL, OMV or equivalent and drilling contractor companies like Schlumberger, Weatherford, Exalo etc or equivalent (belonging to other than manufacturer's own country) in favour of manufacturer must be submitted with the technical offer. If manufacturer has already supplied elevator links to OGDCL then its performance will be evaluated on in house report. The certificates must be on the company letterhead and should indicate the Name & Designation of the signing authority along with his complete contact details phone & fax numbers and his official email address. However above certificate(s) issued by joint ventures and supply/trading house(s) will not be accepted. (Documentary evidence to prove the equivalent stature of E & P company/ Drilling contractors other than specified above will be required alongwith technical bid, to ascertain the equivalency of E & P company/ Drilling contractors other than specified above will be OGDCL sole discretion).
