GENERAL TERMS & CONDITIONS.

1. All the quoted spare parts must have the same part numbers as per SOR. In case of different part numbers quoted, Letter from OEM (M/s CAMERON) to be provided that these part numbers are updated and is exactly for the same item as per SOR (Schedule of requirement).
2. All the quoted spares parts must be brand new & un-used. Bidders to provide Manufacturing date against each quoted item.
3. Genuine parts of OEM i.e. M/s Cameron are to be quoted from OEM or authorized distributors. Valid Authorized distributor letter to be submitted with the Bid.
4. In case Bidder/Manufacturer quote equivalent spare parts with different part numbers then Manufacturer/Bidder have to provide Three (03) numbers satisfactory performance certificates in favour of quoted Manufacturer for each quoted spare issued by authorized official(s) of at least 3 (Three) different renowned international E&P companies like PDO, KOC, Shell, BP, Total, ENI, MOL, OMV or equivalent E & P company or drilling contractors like M/s Schlumberger, M/s Weatherford etc working in other than manufacturer's own country. The submitted Performance certificates should have the wording from the issued E & P or drilling Contractor Company that they have used quoted equivalent spares in M/s Cameron BOP's without any installation & performance issues. The Provided Performance certificates must be on the E & P or drilling contractor company letterhead and should indicate the Name & Designation of the signing authority along with his complete contact details phone & fax numbers and his official email address. However above certificate(s) issued by joint ventures and supply/trading house(s) will not be accepted. (Documentary evidence to prove the equivalent stature of E & P or drilling contractor Company other than specified above will be required along with technical bid, to ascertain the equivalency of E & P or drilling contractor Company other than specified above will be OGDCL sole discretion).
5. The Manufacturer will be required to furnish mill inspection certificate for quoted spare parts with shipping documents. Confirmation to this effect must be provided in the offer.
6. Warranty/Guarantee letter for offered spare parts to be provided for a period of 18 months from date of shipment.
7. Delivery required: - Within Thirty (30) days after establishment of letter of credit on C&F Karachi by Air.
