## TERMS OF REFERENCE (TOR) FOR HIRING OF AMBULANCE AT SINJHORO GAS CONDENSATE FIELD

## GENERAL:

1. The Owner, Oil \& Gas Development Company Limited (OGDCL) is interested in inviting bids for Hiring of a BLS (Basic Lifesaving) Ambulance at Social Welfare CSR Public Dispensary at OGDCL Sinjhoro Gas Condensate Field, Sanghar, in order to provide free medical cover in emergencies to the locals of the vicinity and run the activities of Mobile dispensary at the various well sites of this field. The ambulance besides weekly visits as Mobile dispensary at well site as per schedule will also remain stand by $24 / 7$ at field to meet any emergency. The services vender will provide the driver accordingly.
2. The Quantities contained in the scope of work for each activity are estimated and liable to change (increase, decrease or omitted) when the work is actually executed. The Owner does not expressly or by implication guarantee that actual quantities of work to be performed will correspond to the scope of work submitted with this tender document. The payment to be made to the Contractor shall be based on monthly basis as vehicle rent
3. Unit rates quoted by bidder shall be firm. No extra payments on account of escalation in prices due to any reason shall be admissible.
4. The Owner will provide only fuel for the job \& all other tools, surgical supplies refilling of oxygen cylinders and vehicle maintenance will be borne by the contractor.
5. The items mentioned in the scope of work consist of labor, vehicle \& tools/ accessories repair \& maintenance. The vehicle shall be ready, in all respects in accordance with the requirements and Owner's instructions at site.
6. Quotation is required in PKR
7. Working hours, the vehicle as per nature of the Job will remain ready 24 hours a day 07 days of the weak to meet any emergency.
8. Payment will be made through cross cheque on monthly basis
9. Skilled driver should be well experienced with having valid driving license.
10. Management of the Sinjhoro Gas Field reserves the right to curtail the job list or terminate the services at any time without any reason.
11. HSEQ Rules \& Regulations will be strictly observed.

## OGDCL'S RESPONSIBILITIES:

1- Only Fuel for the vehicle will be provided as per log book / k.m covered.
2- Although the plant has a safe history, however adequate security umbrella as provided to the Company's employees will be extended for Contractor's manpower inside Sinjhoro Gas Field.

## CONTRACTOR'S RESPONSIBILITIES:

1- The technical manpower must be qualified/skilled and have at least three years' driving experience \& can handle the tools inserted in the vehicle.

2- Locals should be given preference while hiring the vehicle.
3- Contractor should prepare/submit daily progress report and percentage Gantt chart (planned vs actual) at end of each day and night shift.

4- Contractor shall provide list of hired manpower along with their CNIC to I/C security before start of ATA for security clearance

5- Contractor shall be responsible for safety of their crew.
6- Contractor shall provide the messing for their crew. No Ta/Da will be given by OGDCL.
7- In case of any accident, OGDCL will provide only general first aid whereas any other medical treatment would be the responsibility of contractor.

8- Contractor will submit Company HSE Policy manual for implementation of safe execution of each activity with zero-injury target. In case of any accident, OGDCL will not be liable for any claim like insurance etc.

9- Contractor shall provide adequate meals and laundry services to their employees.

10-Contractor shall ensure the police verification of all manpower direct and indirect and must have bio-data file of each. (Security concern)

11- Contractor manpower must have CNIC and Contractor identity card.
12- Contractor shall ensure that, their manpower has no any kind of ammunition and narcotics. (Security concern)

13- Mobiles and photo camera are prohibited in the plant premises.
14- All tools and certified equipment's shall be contractor's responsibility.
15-Contractor shall provide all necessary PPE's for their staff.
16- Contractors shall provide all necessary tools, and machines to hired manpower.
17-Contractor shall provide quotation in sealed envelope on their original company letter mentioning NTN and sales tax Number.

18-Contractor shall provide invoices, sales tax invoices (original) Annexure " C " and other related required documents on company letterhead with signature and stamp.

19- OGDCL shall make payment after completion of work through X-Cheque after deduction of Govt. taxes and as per company policy.

20- OGDCL reserves the right to impose penalty on contractor in case of delay of work.
