In case any part not found compatible at the time of installation would be replaced, free of cost.
- 4. Standard OEM warranty is required for the offered parts against defects in performance, material and workmanship and such warranty must be provided with the technical proposal.
- 5. Offered parts to be packed as per OEM standard to ensure safe transportation.
- Bidder to quote each part with complete description, part number, quantity, unit price & extended price.



- 7. Price(s) to be quoted in Pak Rupees (PKR).
- 8. Bidders are required to submit a bid bond of PKR 30,000/- in favor of Operation Manager OGDCL Rig N-6 at Chak 202-1, District Rahim Yar Khan at the time of bid submission.
