6. Any required technical clarification/details regarding coolers to be supplied must be cleared before submission of bid. No change in submitted bid will be entertained after bid submission date.

7. The consignment will be accepted after final inspection at site, and payment will be made through Cross Cheque.

8. The firm should have valid NTN and GST number and have active status on FBR website.

9. The Firm should have active Professional tax certificate of concerned Excise office where operating business.

10. Tax submission Certificate (Annex-C) is to be provided along with Invoice.
