## **TERMS AND CONDITIONS:**

- 1. All bidders should carefully read TOR's attached with the Tender documents before submission of Bid.
- 2. Rate must be quoted against each of the enlisted valves. Evaluation will be based on complete scope of work.
- 3. The evaluation shall be done on the basis of total price without PST.
- 4. Annexure-C with 'submitted' status and proof of deposit of PST (as per rules / regulations of the relevant provincial revenue authority) in NBP should be submitted along with the invoice.
- 5. Boarding & lodging if required by the contractor, shall be provided by OGDCL.
- 6. The contractor shall be required to repair / refurbish valve as per good engineering practices and up to the level of satisfaction of OGDCL.
- 7. Logistics support (Crane, Lifter and Trailer) will be provided by OGDCL.
- 8. Power will be provided by OGDCL.
- 9. All of the required consumables (Seals, repair kits/ service kits, grease, cleaning chemicals etc) will be arranged by the Contractor.

- 10. Contractor will arrange all tools, machines & equipment required for the reaper/refurbishment.
- 11. Contractor will provide required PPE's to its labor.
- 12. Contractor will comply with HSE policy of OGDCL.
- 13. Contractor will follow the safety protocols regarding Corona Pandemic.
- 14. After issuance of formal work order, Contractor is to provide services immediately or at a date mentioned by OGDCL.
- 15. Payment will be made through Cross-Cheque after inspection of completed jobs as per SOR.
- 16. OGDCL reserves the right to inspect, stop and advise rework for any job either during execution or after execution, if deemed necessary by the Company's representative based on quality of the job, finish of the job or if the job is not being or have been performed in line with the best engineering practices. In this regard, the rework will be in Contractor's Scope.
- 17. Contractor must have 5-10 years' of relevant experience substantiated by documentary evidence.
- 18. Partial Payments will not be made, in any case.
- 19. Management of the plant reserves the right to curtail the job list or terminate the services of any hired staff at any time without any reason.
- 20. Contractor should ensure the police verification of all manpower direct and indirect and must have bio-data file of each.
