#### **TERMS AND CONDITIONS:**

1. Delivery period for ordered material will be minimum 04 weeks from the date of issuance of purchase order.
2. Bidding procedure: single envelope, single stage.
3. Evaluation criteria: full consignment wise (all items have to be quoted by a bidder in order to qualify)
4. Bidder to provide unit rate of the element, OGDCL reserve the right to change the required quantity at the time of placement of purchase order.
5. OGDCL reserves the rights to cancel the tender at any stage before placement of firm Purchase Order.

6. Original Bid bond must be submitted along with the bid.
7. Date of Manufacturing shall not be older than 12 weeks having shelf life of 01 year (min.).
8. The offered material must be industrial grade quality, evidence to be provided along with bid documents.
9. Ordered material will be delivered at Nashpa Oil Field. Delivery charges to Nashpa Oil Field are to be borne by the supplier.
10. Shipment shall be delivered in single complete package.
11. Any required clarification/ detail regarding ordered material must be cleared before submission of bid. No change in submitted bid will be entertained after bid submission date.
12. Consignment will be accepted after final inspection at site and payment will be made through OGDCL's standard payment procedure.
13. Supplier should have 02 year of prior experience for supply of material to Oil and Gas, Fertilizer or any other Petrochemical industry. List of relevant POs and company profile to be attached along with the bid.
14. Firm should have valid NTN and GST number and have active status on FBR website.
15. Tax submission Certificate (Annex-C) will be provided along with Invoice.
16. Tax Exemption certificate (if any) has to be submitted with the invoice.
