4 OGDCL will provide only 2 person messing and accomodation facility for contractor's work force during start up of the pump. .Pick and drop will not be OGDCL responsibility .

5	Partial Payments will not be made, in any case.				
6	LD charges @1 % of the cost of entire order (excluding GST) or of such items as remains unsupplied for every day up to maximum of 15% to be applied as penalty in case of Late delivery				
7	Supplier will provide SST/PST invoice/s along with Annex-C for processsing of Payment.				
8	Payment will be made within 90 days after submission of all Invoice documents (Including Annex C) at Field.				
TERMS OF REFRENCE (TOR)					
1	Scope of work consist but not limited to repair and start up of the pump under the supervsion of contractor representative. OGDCL will provide workforce for Pump's unloading, loading and Installation at site.				
2	All the material required for manufacturing of Spare parts for repair of Pump will be contractor's responsibility.				
3	OGDCL will only provide Cone and Tappered roller bearing of Crank Shaft .No spares other than stated earlier will be provided by OGDCL. All other spare parts for repair of pump are contractor's resposibility.				
4	Loading/Unloading and Installation of the pump will be OGDCL reponsibility and start up at site will be performed by contractor in the presence of OGDCL Officials.				
5	Contractor will provide 240 Hrs (10 Days) operational warranty for the aforementioned pump. Any abnormality observed during this perriod will rectified by contractor free of cost.				
6	The contractor must have ISO certification such as QMS ISO 9001:2015, OHSMS ISO 45001:2018, EMS ISO 14001: 2015 in order to ensure credability of the company.Cotractor will have to submit copies of the certification along with bids. Contractor not producing aforementioned certifications at the time of bidding will be deemed as rejected.				
7	Contrcator must visit the pump to ascertain complete scope of work before submission of bid. Any additional scope of work if figured out after submission of bid will be responsibility of contractor. OGDCL will not pay any additional charges for contractor visit at site at any stage.				
8	In case of prolong delay / incompetency observed at any stage.OGDCL may hire any other 3rd party contrcator for subject job on contractor's risk and cost.				
9	Transportation of Pump from Qadirpur Plant to Contractors workshop and Vice Versa will be OGDCL responsibility .				
10	The detail inspection of the Pump will be carried out at site. In case of any abnormality during inspection or operation of the pump, contractor will be responsible to resolve the issue.				
11	Pump must be repaired under OEM guidelines , standards and specifications.
