Bidder must provide with technical bid an authority letter of O.E.M i.e. Sullair USA or their authorized dealer / distributer against this tender enquiry of OGDCL & confirmation on the OEM or their authorized dealer / distributer letterhead that the offered part is new, genuine, unused and free from all manufacturing defects.
- 3. Bidder to submit Sullair LLC USA compatibility certificate along with the technical bid to confirm that all quoted parts are compatible with the compressor's model provided in the tender enquiry and offered parts are new, genuine, unused and free from all manufacturing defects. In case any part not found compatible at the time of installation would be replaced, free of cost.
- 4. Concerned Sullair person name, email and contact number shall be mentioned in OEM (Sullair LLC USA) compatibility certificate in favor of bidder.

- 5. Standard OEM warranty is required for the offered parts against defects in performance, material and workmanship and such warranty must be provided with the technical proposal.
- 6. Offered parts to be packed as per OEM standard to ensure safe transportation.
- 7. Bidder to quote each part with complete description, part number, quantity, unit price & extended price.
- 8. Price(s) to be quoted in Pak Rupees (PKR).
- 9. Bidders are required to submit a bid bond of PKR 30,000/- in favor of Operation Manager OGDCL Rig N-6 at Chak 214-1, District Rahim Yar Khan at the time of bid submission.
- 10. In case, the bidder offers required part(s) with superseded / replaced part numbers, it should be clearly mentioned in the technical / financial bid and a certificate of OEM or their authorized dealer / distributer be provided to confirm that the supplied part(s) with new part number is 100% exact replacement (i.e. 100% compatible in design, dimensions and function / performance) to the part(s) having part number as mentioned in the Schedule of Requirement.
- 11. Installation/ commissioning of the supplied parts/assemblies, if required, will be responsibility of the bidder/ supplier.
- 12. If any clarification is required, it may be obtained from the office of Operation Manager, I/c Rig Maintenance Rig N-6, OGDCL at well # Chak 214-1, Sadiqabad, district Rahim Yar Khan.
- 13. Delivery shall be made within 08 weeks after issuance of purchase order. The material to be delivered at OGDCL Rig N-6 at well # Chak 214-1, district Rahim Yar Khan. In case rig shifted to another location, new address will be shared with bidder(s) accordingly.
- 14. Payment shall be made after delivery, inspection and acceptance by OGDCL against original invoice with annexure C and inspection report duly verified/ signed and stamped by OGDCL Rig N-6 at well # Chak 214-1 district Rahim Yar Khan. Payment will be made to the supplier through Payable Section-Fields at OGDCL Head Office, Islamabad.
- 15. OGDCL reserves the right to annul the bidding process at any time prior to issuance of purchase order/ award of contract.
- 16. Quantity of the required spare parts may be increased or decreased as per OGDCL requirement.
