- 3. Bidders must submit complete tender documents as available on website and having duly stamped and signed at the time of submission of bid otherwise OGDCL reserves the right to reject the bid.
- 4. Transportation of the complete material including pump unit, drilling mud, lowering pipes, water and its loading / unloading at Togh Gas Field, District Kohat is in the scope of the contractor. No mobilization charges shall be provided separately.
- 5. Per unit rate of each and every item should be mention in addition to the items listed above. OGDCL reserves the right to change the scope of supply / services. Payment shall be made as per actual scope of work / services / material supplied based on the unit rate of each material / service.
- 6. The required completion period is 04 months.
- 7. The contractor is required to mobilize to site within 01 month of issuance of work order.
- 8. Water point confirmation through diviner is the responsibility of the contractor.
- 9. Cleaning of bore with compressor will be responsibility of the contractor.
- 10. The material and the equipment to be supplied must be of superior quality. If any material or equipment is found to be of inferior quality, then the contractor is liable to replace the same without any additional cost to OGDCL.
- 11. The minimum specifications of the submersible pump are provided above. The pump to be supplied must be of a reputable brand. 01 year warranty for the complete unit should be provided by the contractor. The pump should be supplied with all accessories including stainer, valves and starting system and should have dry running protection.
- 12. Bids shall be evaluated on the total price of the bid inclusive of GST. Bidders shall clearly mention if he is opting for reduced rate of PST / ICT or full rate of PST / ICT. No change will be acceptable in the option of rate of PST / ICT after submission of the bid. Similarly, at the time of invoicing if any difference in GST is observed, the contractor shall be liable to offer discount in the invoiced amount to OGDCL such that the invoiced amount (inclusive of PST) becomes equal to the price inclusive of taxes as offered in the bid.
- 13. The contractor being registered with respective revenue authority is entitled to charge applicable sales tax over and above its bid price (excluding sales tax) and will be responsible for the payment of such sales tax to the respective revenue authority as per prevailing laws. OGDCL shall reimburse the amount of sales tax to the concerned contractor based on valid payment documents of respective revenue authority.
- 14. OGDCL shall withhold applicable income tax / PST / ICT as per prevailing withholding rules.
- 15. Accommodation to the workers and supervisor of the contractor will be the whole responsibilities of the contractor. No Accommodation, pick and drop will be provided by OGDCL.
- 16. All tools and accessories including utility water for construction will be the responsibilities of contractor.
- 17. All HSEQ Policy of OGDCL will be follow in true spirit and PTW will be follow during job execution and in case of any violation or any damage of materials /manpower will be the responsibilities of contractor.

- 18. The unit rates and prices in the Schedule of Prices shall be quoted by the bidder in the currency PAK. Rupees
- 19. Each bidder shall furnish, as part of his bid, at the option of the bidder, a Bid Security in the amountstipulated in Bidding Data in Pak. Rupees in the form of Bank Draft/Call Deposit Pay order or Bank Guarantees per format provided) in favor of Employer valid for a period up to 28 days beyond the bid validity date.
- 20. Bids must be received by the Employer at the address/provided in Bidding Data not later than the time and date as mentioned in the WEB advertisement.
- 21. The Employer will award the Contract to the bidder whosebid has been determined to be substantially responsive to the Bidding Documents and who has offered the lowest evaluated Bid Price, provided that such bidder has been determined to be qualified to satisfactory perform the Contract in accordance with the OGDCL standard demand.
- 22. Bid shall be quoted entirely in Pak. Rupees. The payment shall be made in Pak. Rupees. Payment will be made through cross cheque after completion of the job activities in all respect. Including housekeeping.
- 23. Period of the bid validity 100 calendar days. The bid validity period may be extended by the bidder in case of expiry of the bid validity, at the request of the employer. If the contractor will not extend the bid validity, then his bid security may be released without any forfeiture. The Bid is valid till required period, the Bid prices are firm during currency of contract. The Contract shall be for the whole of the Works as described in these Bidding Documents. Bids must be submitted for the complete scope of works.
- 24. Unless otherwise stipulated in the Contract Data, the rates and prices entered by the bidder shall not be subject to adjustment during the performance of the Contract. All duties, taxes and other levies payable by the Contractor shall be included in the rates and prices. The whole cost of complying with the provisions of the Contract shall be included in the items provided in the Schedule of Prices, and where no items are provided, the cost shall be deemed to be distributed among the rates and prices entered for the related items of the Works and no separate payment will be made for those items.
