**TERMS AND CONDITIONS**

Sealed bids are invited under Competitive Bidding Procedure on Single Stage single Envelope Bidding Procedure. The bid shall contain both financial proposal and technical proposal.

01. Bidders are required to download the master set of tender documents from [www.ogdcl.com](http://www.ogdcl.com) under the title "Tender". Bidder shall follow the instruction mentioned in the master tender documents.
02. 100% payment will be made through cross cheque only payable to supplier's company after completion of assignment and submission of invoices, GST invoices and FBR Annex C where applicable with required documents and completion of store and accounts procedures.
03. The payment shall be made as per actual against verified invoice from I/C Electrical & Plant Manager.
04. All admissible taxes will be deducted as per rules.
- 05. Power cable for full load capacity for three phase with neutral with lugs shall be provided by the supplier / contractor with the generator. The length of each cable must not be less than 10 meters.**
- 06. The supplied Generator shall be equipped with control panel having necessary protections and circuit breaker according to load requirement.**
- 07. Generator voltage level shall be 400VAC Three Phase and 220/230VAC on single phase at 50 HZ frequency.**
08. Transportation/Mobilization & de-mobilization of gas generator will be on the part of the supplier.
09. Unloading & loading of gas generator will be provided by OGDCL at site under suppliers supervision. OGDCL will not be responsible for any damage occurred during unloading / loading of gas generator.
10. Operation/servicing staff will be provided by the supplier.
11. OGDCL will provide accommodation for only 03 Nos of operation/servicing staff.
12. OGDCL will provide supply of fuel gas and water only at site for gas generator.
13. OGDCL will not be responsible for any damage/loss to generator at site during operation.
14. Installation & Commissioning of supplied generator will be done by the supplier.
15. Servicing of the generator, routine maintenance, Top End, Mini & Major Overhauling trouble shooting will be done by the supplier.
16. Lubrication and supply of necessary consumables like lube Oil, lube Oil Filters, Air Filters & gas generator parts shall be supplied by the supplier.

17. Stationary to maintain the Gen Set record shall be supplied by the supplier and complete logging shall be provided after completion of assignment.
18. Last maintenance record, Total Running Hours and Year of manufacturing of supplied generator shall be provided by the supplier in technical evaluation.
19. The supplied generators shall be capable (as a prime source ) to cater continuous residential camp loads 24 hours for electricity and air conditioners use as per generator rating.
20. The contract time will start when generator to be put on load by the site team.
21. In case of complete failure of generator set, the supplier has to provide replacement within 12 hrs of gas generator having same capacity.
22. In case of malfunction / stoppage of gas generator at site, the deduction will be made in the following manner:

a	Continuous stoppage for more than 06 hrs.	Deduction of full day payment .
b	Continuous stoppage for more than 12 hrs.	to replace the generator set with deduction of 02 full day payment.
c	Failure to replace/repair the gen set within 24 hrs.	the contract will be cancelled without any claim.

23. Bidders are required to quote in Annex "C" format. Price quoted shall include all applicable taxes.
24. The supplier will have minimum of 05 years of past experience in the supply of same item.
25. Supply from gas generator will be required to start from tentative date i.e. July 22 to August 15, 2023 for 25 days. However, OGDCL will inform regarding mobilization of gas generator one week before ATA.
26. The supplier shall mobilize generator one week before ATA-2023 to install and check at site and generator shall be ready to start before ATA-2023 tentative date.
27. The tender committee reserves the right to increase or decrease the number of days on same rates or may cancel the tender without assigning any reason thereof. The payment will be made according to days, the generator utilized.
