- 6. Inspection may be carried out at OGDCL site and after successful inspection of mechanical seals will be accepted.
- 7. Payment will be made through cross checque and will payment be released when once successful inspection of material at site is completed. OGDCL has the right to reject whole or part of supplied material if inspection results found unsatisfactory.
- 8. Any damaged seal found during inspection will have to be replaced by the supplier without any extra charges.
- 9. Supplier to provide all necessary documents like Annex-C (Tax), professional tax certificate etc with invoice.
- 10. The material will be delivered at Dakhni Plant, the delivery charges to Dakhni gas processing plant to be borne by the supplier / bidder.
- 11. 1-year warranty/guarantee for the services must be provided.
- 12. Bidder should submit complete/clean acceptance of OGDCL TOR.
