TERMS OF REFERENCES (TOR) FOR SUPPLY OF H2S SCAVENGER FOR DARU GAS DEHYDRATION PLANT

- 01. Bidder must have previous experience in supply of same chemicals. Verifiable list (supported by documentation such as purchase orders) must be provided, besides unpriced copy of contract, purchase order with name and full contact details to be provided in technical bid.
- 02. Data sheets of the H2S Scavenger will be furnished along with the delivery.
- 03. Qualified bidder will be bound to provide material as per mentioned specifications.
- 04. Without any extra charges, rejected items will be replaced/exchanged by bidder.
- 05. Payment will be made after 100% delivery, subject to acceptance of material by inspection committee at Daru Plant.
- 06. Delivery period for material is 6 weeks from the date of issuance of Purchase order.
- 07. The material will be delivered at Daru Gas Dehydration Plant, P.O. Tando Muhammad Khan, Distt Tando Muhammad Khan, the delivery charges to Daru Plant to be borne by the bidder.
- 08. OGDCL can increase or decrease the quantity of the chemical.
- 09. OGDCL reserves the right to cancel the case without any explanation prior to the award of purchase order.
