7. OGDCL, Uch Gas Field will provide Transportation & accommodation to the manpower of successful bidder at Uch Gas Field site, provision of food will be contractor/supplier responsibility.
8. Bids evaluation criteria will be full consignment wise.
9. Bidder shall mention warranty period of each item separately in its technical bid.
