SCOPE OF WORK:

Hiring of Technical Services for Pre-Fabrication jobs at Mela (as per scope of work attached)

TERMS AND CONDITIONS

1. Logistics support (Crane, Lifter and Trailer) will be provided by OGDCL as per requirement.
2. Scope is inclusive of 1700 Dia. Inch welding and rates to be quoted on per dia inch basis. OGDCL will provide isometric drawings.
3. OGDCL will only provide boarding facility. Messing/food will be in contractor scope.
4. Power will be provided by OGDCL for jobs performed in plant workshop. For well site, the contractor will arrange power facility at its own.
5. All types of Consumables (Welding Electrodes, Cutting/Grinding discs, Filler wire Oxygen & DA Cylinders, Argon Gas etc.) will be provided by Contractor.
6. Contractor will arrange all tools, machines & equipment (including portable welding machines, grinding & cutting machines etc) required during welding/fabrication.
7. Contractor will provide required PPE's to its labor.
8. Contractor will comply with HSE policy of OGDCL.
9. After issuance of formal work order, Contractor is to provide services immediately or at a date mentioned by OGDCL.
10. The estimated scope of work is liable to change (increase, decrease or omitted) at the stage of execution. The payment will be made on the actual quantity of work performed.
11. OGDCL reserves the right to inspect, stop and advise rework for any job either during execution or after execution, if deemed necessary by the OGDCL representative based on quality of job in line with the best engineering practices. In this regard the rework will be in Contractor's Scope.
12. Contractor must have minimum 10 years of experience of Welding & fabrication jobs in oil & gas sector.
13. Management of the plant reserves the right to curtail the job list or terminate the services of any hired staff at any time without any reason.
14. Contractor should ensure the police verification of all manpower direct and indirect and must have bio-data file of each individual
15. Pressure testing and surface preparation for NDT will also be in contractor scope.
16. Contractor to perform the job in expeditious manner so as to complete the job as per timeline provided by OGDCL during execution stage and will depute sufficient manpower and machinery to meet the target given by OGDCL.
