#### **TERMS AND CONDITIONS:**

- 1. The material will be delivered at Nashpa Oil Field. The delivery charges to Nashpa Oil Field to be borne by the supplier/bidder.
- 2. Traceable MTC of the material along with valid heat number & mail address of manufacturer/trader must be provided. If MTCs are not verified by the manufacturer/trader, the material will be rejected.
- 3. Any required technical clarification/detail regarding material to be supplied must be cleared before submission of bid. No change in submitted bid will be entertained after bid submission date.
- 4. Make, origin, material specifications & size should be clearly mentioned on material/supporting documents
- 5. Gaskets of Flexitallic or equivalent brand must be quoted
- 6. Technical & Financial evaluation will be made on the complete scope of supply.
- 7. The material must be supplied within 02 weeks from the date of PO placement. In case of late delivery OGDCL reserve the rights to cancel PO. In case of extension of delivery time needed due to force majeure, a written request should be sent to chairman of the committee within material supply time period
- 8. Certificate of Origin to be provided by vendor at the time of delivery.
- 9. Material will be accepted after final inspection at site. If any change in specifications of any item supplied, with respect to mentioned in bids, is observed the entire material will be rejected. Collection of material from Nashpa will be the responsibility of the supplier at his own arrangements of loading/transportation.
- 10. The firm should have valid NTN, GST numbers and active status on FBR website.
- 11. The Firm should have active Professional tax certificate of concerned Excise office where operating business and same to be submitted along with the bid.
- 12. Tax submission Certificate (Annex-C, submitted status) should be provided along with Invoice.
- 13. BOE, GD or SRO to be submitted along with invoice for Income tax/GST exemption if any.
- 14. The supplier should have 10 years of prior experience of supply of piping material.
- 15. No advance payment will be made. Payment will be made after completion of company procedure (which may take time).
