#### TERMS AND CONDITIONS:

- 1. Logistics support (Crane, Lifter and Trailer) will be provided by OGDCL only for shifting, loading and unloading Pipe from store yard to area and shifting of existing line form area to scrap yard
- 2. Electricity will be provided by OGDCL for Welding job
- 3. All kinds of material for Civil work are in contractor scope
- 4. OGDCL will provide Pipe, and supports material
- 5. All types of Consumables (Welding Electrodes, Cutting/Grinding discs, Filler wire Oxygen & DA Cylinders, Argon Gas etc.) will be in Contractor scope
- 6. The contractor will arrange all tools, machines & equipment (including portable welding machines, grinding & cutting machines etc.) required during welding/fabrication.
- 7. Boarding & lodging will be arranged by contractor
- 8. Pressure test of newly fabricated line is in contractor scope. Water for testing will be provided by OGDCL.
- 9. The Contractor will comply with HSEQ policy of OGDCL.
- 10. After issuance of formal work order, Contractor is to provide services immediately or at a date mentioned by OGDCL.
- 11. The estimated scope of work is liable to change (increase, decrease or omitted) at the stage of execution. The payment will be made on the actual quantity of work performed.
- 12. OGDCL reserves the right to inspect, stop and advise rework for any job either during execution or after execution if deemed necessary by the OGDCL representative based on quality of job in line with the best engineering practices. In this regard the rework will be in Contractor's Scope.
- 13. The contractor must have a minimum of 10 years of experience of Welding & fabrication jobs in Oil & Gas sector.
- 14. Management of the plant reserves the right to curtail the job list or terminate the services of any hired staff at any time without any reason.
- 15. Contractor to perform the job in expeditious manner to complete the job as per timeline provided by OGDCL during execution stage and will depute sufficient manpower and machinery to meet the target given by OGDCL.
- 16. Technical & Financial evaluation will be made on the complete scope of supply.
- 17. Any required technical clarification/ detail regarding scope of work must be cleared before submission of bid. No change in submitted bid will be entertained after bid submission date.
- 18. Payment will be made through Cross cheque after provision of Tax Submission Certificate (Annexure-C).
- 19. The firm must have valid NTN and GST numbers and have active status on the FBR website.
- 20. The Firm must have an active Professional tax certificate of concerned Excise office where operating business, all these documents will be submitted as part of Bid.
