TERMS AND CONDITIONS:

- 1. The Bidding Procedure will be Competitive Bidding (Single Stage, Single Envelop System)
- 2. Delivery period for the Services at Bettani Oil and Gas Field will be 03 to 04 weeks from the date of issuance of purchase order.
- 3. The Expenditure of mobilization of the teams/ Equipment to Bettani Oil and Gas Field to be borne by the supplier/ bidder.
- 4. Any required technical clarification/details regarding material to be supplied must be cleared before submission of bid. No change in submitted bid will be entertained after bid submission date.
- 5. Bidder shall have to provide Catalogues/Brochures of the offered brands showing clearly the origin of the product. Technical Evaluation will carried out on the basis of supplied data.
- 6. All Equipment will be inspected on delivery for quality and workmanship on delivery. If found unsatisfactory then supplier shall have to replace the same within a week.
- 7. Unbranded/Counterfeit items shall not be acceptable.

- 8. Equipment will be accepted after final inspection at site, and payment will be made through OGDCL Head Office after successful commissioning of the said panel.
- 9. The Bidding Firm must have at least five years of working experience with such type of PLC Panels and must attach their working proof along with the bid.
- 10. The firm should have valid NTN and GST number and have active status on FBR website.
- 11. The Firm should have active Professional tax certificate of concerned Excise office where operating business.
- 12. Tax submission Certificate (Annex-C) will be provided along with Invoice.
- 13. BOE, GD or SRO to be submitted along with invoice for Income tax/GST exemption if any.
- 14. Bid evaluation will be as per complete Scope of the tender.
- 15. Attach a Bid Bond of Rupees 30,000/- in Favor of Field Manager Bettani Oil and Gas Field Lakki Marwat.
