- 1. Heavy duty **Dozer CAT D8K, D8N, D8R, KOMATSU D-155** or equivalents with ripper, not older than model 2000 should be in good working condition and capable for smooth working in hilly area to be quoted by bidders.
- 2. The bidders must specify Make, Model, and Year of manufacture, of the machine to be supplied in his bid.
- 3. Only diesel will be provided by OGDCL. Mobilization / demobilization and all types of repair / maintenance including parts, Filters and lubricants will be responsibility of the bidder.
- 4. In case of any breakdown the bidder will replace the Machine on first simple and written notice without any arguments or litigation and in case of failure to replace the broken down machine liquidated damage clause can be applicable.
- 5. OGDCL will not be responsible and no payments will be made against any sort of road mishap, accident, injury, death, force majeure or any unforeseen, loss and damage to the machines and driver / contractor employees, or any other person or installation due to machine.
