- 3. Bidders to provide previous supply references within Pakistan.
- 4. Delivery period for material is 08 weeks from the date of issuance of Purchase Order.
- 5. If the supplier fails to deliver the goods within the delivery period, then Late Delivery / Liquidity Charges shall be applicable as per OGDCL's Rules.
- 6. Supplier shall submit Material Specification and Country of origin confirmation from OEM along with technical bid.
- 7. Material will be delivered at Chanda Oil Field-OGDCL in original OEM packing free of cost on FOR basis.
- 8. Inspection of material will be carried out by the OGDCL rep. at Chanda Oil Field.
- 9. Off spec and deteriorated items will be rejected during inspection and to be replaced by the supplier without any claim/charges of transportation or courier.
- 10. Supplier to ensure standard performance guarantee of 6 months after receipt, inspection and acceptance of material.
- 11. Bids evaluation will be Group wise. (Group A: Spiral wound gaskets, Group B: RTJ)
