SCOPE OF WORK:

1. Welding, Cutting, Beveling and Installation of interconnecting pipe spools of Crude Oil Loading Gantry, Drain line from Separator & tanks to API Pit and other Miscellaneous fabrication activities.
2. Estimated dia. inch for fabrication approximate 2600 dia. inch (depending on site conditions).
3. Installation & bolting of fabricated pipe spools at designated location.
4. Air purging of installed lines.
5. Hydro testing of line segments and vessels as required by OGDCL reps.

TERMS AND CONDITIONS

1. All participants should carefully read TOR's attached with the Tender documents before submission of Bid.
2. All participants are encouraged to visit Nashpa Field to understand WPS and standards required to be followed for job execution and completely eliminate any source of confusion before bidding.
3. Bidder must provide prior experience certificates of welding, fabrication and commissioning along with bid documents.
4. Bids to be provided on per Dia. inch basis
5. After issuance of formal work order, Contractor is to provide services immediately or at a date mentioned by OGDCL.

6. Contractor must provide prior experience certificates of its Supervisors, Welders & Fabricators.
7. Prequalification of Welders as per OGDCL requirements is necessary and OGDCL reserves complete right to accept/ reject the welder and Contractor will be bound to provide replacement without any delay.
8. Contractor should ensure the police verification of all manpower direct and indirect and must have bio-data file of each.
9. The Quantities contained in the scope of work for each activity are estimated and liable to change (increase, decrease or omitted) when the work is actually executed. The payment to be made to the Contractor shall be based on the actual quantity of work performed.
10. OGDCL reserves the right to inspect, stop and advise rework for any job either during execution or after execution, if deemed necessary by the Company's representative based on NDT reports, quality of the job, finish of the job or if the job is not being or have been performed in line with the best engineering practices. In this regard the rework will be in Contractor's Scope.
11. NDT for 100% joints will be carried out by third party as appointed by OGDCL.
12. Hydro-testing if required with water will be in contractor's scope, OGDCL will provide water.
13. Contractor is to abide by all safety Rules and Regulations of OGDCL.
14. All Kind of Equipment, Tool & Consumables (Welding Electrodes, Cutting/Grinding discs etc.) will be in Contractor's scope.
15. Contractor will provide all kind of PPE's to its labor.
16. Logistics support (Crane and Trailer) will be provided by OGDCL.
17. Utilities Electricity, Water etc. will be provided by OGDCL.
18. OGDCL will not provide boarding/lodging and messing to the manpower of contractor. However area will be designated for contractor to set up his own camp.
19. Payment will be made through Cross Cheque after inspection of completed jobs as per SOR.
20. Partial Payments will not be made, in any case.
21. Contractor will submit necessary documents including the following for invoicing at the successful completion of the job:
 - a. Commercial Invoice
 - b. Services Tax Invoice
 - c. Annexure-C
 - d. Account Details on Letter Head
 - e. Professional Tax Certificate
22. The Contractor should have valid NTN and GST number and have active status on FBR website.
23. The Contractor should have active Professional tax certificate of concerned Excise office where operating business, all these documents will be submitted as part of Bid.
