### **General Terms & Conditions**

A vehicle Vigo 4x4 (Double Cabin) with following specification is required to be hired at wellsite in the North Region (District Lakki Marwat) at Rig SLR-225, Bettani Deep - 01, to meet its operational requirements. Beside to and from movement from field to field, the vehicle will also be utilized to facilitate purchases, repair of tools/ accessories from local/ capital market and receipt/ dispatch of documents/ gadgets from/ to OGDCL Head Office, Islamabad. The following is the detail of required vehicles: -

Note: Bids not fulfilling the above mentioned criteria will be disqualified.

- I. Vehicle is to be hired on "As & when required basis" for the new drilling project at aforementioned Rig/well & region.
- II. The bidder shall be required to submit a **lump sum** monthly rate for the said vehicle including all expenses and applicable federal/provincial taxes, levies, sales tax etc. The quoted amount shall be deemed to be "Financial evaluation".
- III. The driver salary overtime or daily allowance (if any) will be in the account of the contractors.
- IV. The contractor shall submit invoices on monthly basis. OGDCL will deduct income tax and other levies, sales tax etc. (if any) from the invoice amount as per prevailing federal/provincial laws.
- V. Bidder shall furnish valid tax registration certificate i.e. NTN and PST and business place/address" and telephone no.
- VI. P.O/DO in the form of bank guarantee to be submitted along with earnest money/surety bond bid equal to 2% of the annual rental amount for the vehicle.
- VII. The successful bidder will be required to submit a **performance bond** equivalent to 10% of the total contract value for the region.
- VIII. The duration of the agreement will be as stated above which will be renewed (if required) for the next period on the same terms and conditions.
- IX. OGDCL reserves the right to terminate the Agreement on fifteen days' notice without assigning any reason and without incurring any liability.
- X. The vehicle with a driver will be deployed for 24 hour services as required at the discretion of OGDCL.
- XI. Accommodation of driver at rig site during field duty will be provided by OGDCL however food expenses will be responsibility of driver/contractor.
- XII. Fuel (HSD) will be provided by OGDCL as per policy but filter and engine oil will be contractor's responsibility.

- XIII. In case of breakdown of the vehicle, the contractor shall immediately provide a suitable replacement of the vehicle. No, payment will be made for the day the vehicle is not provided. It does not apply during strike or law and order situation in the city.
- XIV. The Contractor shall maintain the Vehicle in good running condition at all times. Vehicle will be sent for major repair/maintenance only at contractor's location/workshop if required.
- XV. The contractor shall at all times be responsible for the safety and security of the vehicle and OGDCL shall not be responsible or liable for any accident, theft, loss, damage etc. due to any reason whatsoever.
- XVI. OGDCL reserves the right to accept or reject any bid or cancel the bidding process and reject all bids as per PPRA Rule 33.
