Section-I

### Introduction

OGDCL is a public limited company engaged in exploration and production (E&P) activities in the country for the last six decades. OGDCL intends to engage a reputable Certification Body to carry out OHSE certification/ surveillance audits of OGDCL House against the requirements of ISO 14001 and ISO 45001 standards. Therefore, this document is being developed to explain the scope of work for a Certification Body to provide auditing services for Certification of OGDCL House Islamabad.

#### Section-II

### Objective

As part of continual improvement of OGDCL OHSE management system, the company aims to acquire Certifications of OGDCL House against the requirements of ISO 14001 and ISO 45001 standards. Certification/ surveillance audits shall be carried out in order to determine whether OHSE management system of OGDCL conforms to the requirements of standards.

## Scope of Work

- Certification and surveillance audits of OGDCL House for administration function including maintenance, IT/ communication, security, catering, medical and transportation services.
- While conducting certification audits and subsequent surveillance visits of OGDCL House, following are required from the Certification Body:
  - Honor any existing compliance certifications/ NOCs during conducting the audits,
  - Provide trainings on the elements of OHSE management system to remove gaps,
  - Submit detailed audit report mentioning the implementation status of recommendations pertaining to any previous audits, &
  - Communicate critical matters witnessed during the audit having significant impact on the sustainability of the business in the building.

## **Instructions to Bidder**

- Auditors will be approved by OGDCL prior to carrying out the activity.
- © Certification Body should be capable of providing Accredited Certifications and should have expertise/ technical resource available for the requisite activity.
- · Certification Body should possess minimum five year experience of auditing and providing trainings and certifications in the field OHSE management systems.
- Auditors designated for the requisite activity should be approved Lead Auditors from IRCA (International Register of Certificated Auditors) and possess at least ten year experience of trainings and auditing in the field OHSE management systems.
- A list of Auditors should be provided along with their CVs well before execution of the activity.
- Lead Auditor will prepare and submit specific Audit Plan for review to OGDCL. Audit team will adopt following methodology:
  - Kickoff meeting
  - Examination of the data & record (documented information)
- Talking to personnel actually performing various tasks under the scope of work
- Observing tasks/ operations being carried out under the scope of work
- Validating safety critical equipment to see whether fit to address emergencies
- Closeout Meeting

- Auditors will ensure to focus and spend more time on significant areas and activities with high risks keeping in view time management as one of the crucial factors of OHSE audit and trainings.
- Auditors will ensure proper handling and reporting of sensitive information applying due diligence.
- Auditors will remain impartial, free from bias & conflict of interest, and maintain integrity and objectivity throughout the audit process to ensure that audit findings and conclusions are based on audit evidence.
- Whenever there are changes in the standard during the contract period, the Certification Body should be able to provide services according to the latest version of the standards.

  - Complete company profile mentioning details of services provided.

- In case, any critical/ major nonconformity is detected in the HSE System which demands certain time specific remedial action(s), then the Certification Body shall conduct a single-man-day verification/ follow-up audit on a mutually agreed date and shall charge on the basis of unit rate mentioned in the Service Order.
