

TERMS OF REFERENCE (TOR)


1. OGDCL intends to hire services of a contractor's/Firms for hiring of trailers and cranes for Field Units of Logistic Department on call out basis.
2. Company/Firms will quote rent for Trailer on per kms rent charges for trailers and cranes on per day charges (24 Hours) on call out basis as per TOR and it shall be inclusive of all taxes levies overhead charges profit and other expenditure as per schedule "A" on your Company/Firm original Quotation Pad exclusive of PST/ICT.
3. Contract will be awarded to the lowest quoted rate of the technically responsive bidder.
4. Neither the Contractor/owner/director/partner of the firm/company /vehicles should employee of OGDCL and nor the relative of the employees of OGDCL.
5. HSD, Toll Tax, all types of repair, Maintenance, replacement of Filters, engine oil and Tyres etc. shall be the responsibility of the contractor/ firm/company.
6. Contractor shall replace the vehicle in case of its break down/ vehicles hold by any law enforcement agency on first simple and written notice without any arguments or litigation. Any failure to replace the broken down/ holds vehicles within 3 days, a penalty equal to double per day per vehicle rent charges will be imposed / deducted. Further shall be deal as per OGDCL Rules.
7. Any damage of OGDCL material during shifting through private trailers is the responsibility of contractor. The contractor will pay the loss assessed by OGDCL officials.
8. The Vehicles should be in accordance to HSEQ policy, with perfect hygienically, mechanically and satisfactory working conditions. The contractor shall also ensure that the vehicles are well maintained and their appearance both in interior and exterior is in excellent condition.
9. The contractor to perform Drug testing of Drivers and helpers at least once a year, OGDCL may request more frequent testing from contractor in case of accident/incident or random testing at no cost to OGDCL. The Contractor should provide physical checkup and fitness certificate of the drivers/helpers on annual basis.
10. The contractor shall ensure that the papers of vehicles (Registration, road permit and regulatory requirements, tax and insurance documents, token Tax and pollution / annual fitness certificate from regulatory authority etc.) are complete in accordance with government laws. All vehicles provided should be comprehensively insured at no additional cost to OGDCL.
11. The rate quoted by the contractor shall be inclusive of all taxes (except ICT/PST), levies, cost of drivers & helpers, and all maintenance, tracking system / Fuel level sensors and other expenditures. It shall remain firm during the contract period.
12. The utilization of the vehicles/Trailers will be used as per instruction of Logistic Location In-charge to all fields / locations all over within the country on plane and rough terrain, where and when required.
13. Contractor shall be responsible for violation of traffic rules & misconduct of drivers. OGDCL shall have the right to demand replacement of a driver/ helper in case of misconduct/ illegal activities or repeated violation of traffic rules.
14. Contract Period for hiring of vehicles (Trailers) for Field Units of Logistic department shall be one year (12) months from the date of hiring of vehicles, However, any extension in the contract shall be with mutual consent of the both parties.
15. In Case of any dispute, Suspension of work and default, the matter will be deal as per OGDCL contract clause # 17 "Arbitration".
16. No escalation shall be allowed on account of fluctuation in market rates during the contract period.

17. The load carrying/ lifting capacity of each trailer should be fit for the route in plain and hilly areas, as per current logistic movement practice.
18. The contract may be terminated as per contract clause # 18 "Termination"
19. After award and during contract period, if the services are no more required or the contractor fails to abide by the terms of the bid documents or violate the same or do not follow the instruction of the Location workshop in-Charge or take no remedial /Correction measures after receiving written notice from the Location workshop in-charge.
20. All pages of TOR, BOQ and other documents must be stamped and signed by the contractor or his authorized representative who have authority letter in this regard. The Bid on behalf of a Joint venture shall be signed by all the partners or by an authorized partner who have authority letter in this regard.
21. The distance for services will be confirmed by OGDCL by OGDCL as per OGDCL systems (distance chart etc.) and OGDCL decision will be final in this regard.
22. The quantities shown are only for evaluation purpose. The payments will be made on the actual services accepted by OGDCL and performed by the contractor.
23. OGDCL reserves the right to accept any or reject all bids. No claim shall be made by the bidders participated in the bidding process in this regard.
24. OGDCL standard Terms and Conditions will apply.
25. The company has to provide its own or third party (i.e. leasing) hired vehicles.






