**HIRING OF SERVICES OF RTTS, CEMENT RETAINER WITH

SCOPE OF WORK

RETRIEVABLE PACKER AND CEMENT RETAINER SERVICES

**A. RETRIEVABLE PACKER 14", 13-3/8" (48 – 114 LB/FT), 9-5/8" (42.5 – 53.5 LB/FT), 7" (29 – 35 LB/FT) AND 5" (18-20 LB/FT)**

- i. Operating charges (per day).
- ii. Standby charges (per day).

**B. CEMENT RETAINER 14", 13-3/8" (48 – 114 LB/FT), 9-5/8" (42.5 -53.5 LB/FT), 7" (29-35 LB/FT) AND 5" (18-20 LB/FT)**

- i. Cost of easy drill cement retainer (per piece for each above mentioned packer).

**C. HST/MST & STINGER FOR CEMENT RETAINER 14", 13-3/8" (48-114 LB/FT), 9-5/8" (42.5 – 53.5 LB/FT), 7" (29 – 35 LB/FT) AND 5" (18-20 LB/FT).**

- i. Operating charges stinger only (per day).
- ii. Standby charges for stinger (per day).
- iii. Operating charges, MST/HST only (per day).
- iv. Standby charges for MST/HST (per day).
- v. Charges of matching wire line kit to set retainer.

**D. MOB/DEMOBS.**

- i. Mob/demob charges of RTTS , Cement Retainer , MST/HST and stinger to location will be charged as under
  - For wells in Punjab and KPK mob/demob will be given from Islamabad
  - For wells in Sindh and Baluchistan mob/demob will be given from sukkar

**E. PERSONNEL.**

- i. Operating charges of crew per day.
- ii. Standby charges of crew per day.

F. **MOB/DEMOBS OF CREW**

- a) Lump sum mob/demob charges per trip for each OGDCL Rigs.

G. **MAGNITUDE OF JOB**

Approximately 06 jobs per Annum.

Note: Number of job may be increased or decreased as per requirement.

H. **ESTIMATED VOLUME OF WORK**

Estimated volume is 18 jobs in three years approximately.

I. **DISTANCE.**

Distance Map of OGDCL Fields/Wells is attached at Annexure "A-4", however for any new Locations distance given by the OGDCL will be considered final.

**Note:**

- i. For each crew, number of persons with discipline should be mentioned.
- ii. For any clarification, Services company can contact procurement Department.
- iii. The rate quoted for each service/material will be valid for next three years from the date of awarding contract. Contract will not be extended further.
- iv. It is to be noted that evaluation of bid will be made on package basis i.e RTTS , Cement Retainer and accessories with crew services.
- v. Services companies to submit their complete price list of their products and services to get the service/material not mentioned in above data (if required). The rate mentioned in the price list will be **valid for next three years from** the date of awarding contract. But it will not be a part of contract.
- vi. Services company will provide the import documents and manufacturing details including name of manufacturer, country and year of manufacturing of all the equipment required for this contract.
- vii. The equipment should be less than 10 years old.
- viii. Prices quoted will be inclusive of all taxes except (ICT/PST).

**CRITERIA FOR TECHNICAL QUALIFICATION**

Evaluation of technically qualified Services company will be based on merit. The minimum selection criteria will be 85% aggregate. The weight age percentage allocated for each discipline is shown below
