TERMS AND CONDITIONS FOR SUPPLY:

1. The supplier of pipes & fittings will have minimum of 05 Years of past experience in the supply of same items.
2. Testing certificates/ MTC's has to be provided by the supplier otherwise the material will be rejected during inspection.
3. The manufacturing of mentioned pipes & fittings should be as per ASME codes & standards.
4. The material should be NACE compliance MR-0175.
5. Delivery period for material is 4 weeks from the date of issuances of Purchase order. Delivery should be full consignment, partial shipment not allowed.
6. Single stage, single envelop bidding will take place along with Item wise evaluation criterion for the bids. Bidder should submit the Bid Bond value Rs.60,000/- (Pay Order) at the time of bid submission. Otherwise bid will not be accepted.

7. The material will be delivered at Dakhni Plant, the delivery charges to Dakhni gas processing plant to be borne by the supplier / bidder.
8. Bidder/ supplier should quote full consignment wise. Partial quote is not acceptable.
9. Payment will be made through cross cheque after complete inspection of full consignment, submission of annexure C with sales tax invoice. OGDCL has the right to reject consignment if inspection results found unsatisfactory.
10. Any damaged pipe/fitting found during inspection will have to be replaced by the supplier without any extra charges.
11. Brand new pipes & fittings items of reputed European/korean brands is required and if any item found damaged or sub-standard will be rejected during inspection.
