- 6. Single stage, single envelop bidding will take place.
- 7. Custom clearance is in supplier's scope.
- 8. The material will be delivered at Dakhni Plant on FOR basis, the delivery charges to dakhni gas processing plant to be borne by the supplier / bidder.
