**HIRING OF WORKSHOP SERVICES FOR PREMIUM CONNECTIONS**

## **SCOPE OF WORK**

1. OGDCL invites comprehensive and competitive proposals from the service companies of National / International repute for hiring of workshop services for premium casing connection for a period of three years, extendable with mutual consent.
2. The successful service company is to provide workshop services for OGDCL casing repair. The volume of work will increase or decrease according to Company's requirement on as and when required basis.
3. The workshop services will include following facilities:
  - a. Premium Casing connections rethreading/recut and repairing/rethreading of casing Connection as Per API-5CT, fabrication of X-overs and circulating heads etc.
  - b. In order to assess capability for provision of services, the bidders will have to provide equipment list with year of manufacturing with proof and established base in Pakistan as per given list & technical data with inventory quantity. The presence of equipment in vendor's workshop is mandatory, OGDCL team may visit to verify the same. Or assurance to establish the base in Pakistan within 120 days of signing of contract with undertaking to provide necessary equipment for workshop services.

## **TERMS OF REFERENCE**

The Company envisages to invites proposals from reputable Services Companies to submit competitive bids to provide workshop Services on as and when required basis contract for a period of three years on the following terms, which is extendable with mutual consent.

1. Bidders to quote the services on full consignment basis.
2. Technical evaluation criteria of Machine shop services will be as per Annexure-A and rate format is available at Annexure-B.
3. Financial evaluation criteria will be full consignment wise as per Annexure-C.
4. Reputable oilfield Machine Workshop Service Companies having minimum 04 years active experience of such services are invited to participate in bidding process.
5. The bidder will provide the list of machines date of manufacturing with third party certifications for all the machines working for the contract.
6. The Machine shop professional offered for the services will have minimum of 05 years field experience of the similar jobs. CV's to be attached with technical proposals.
7. The bidder will provide the Proof to support the experience of the Company, detail of Machine shop contracts for the last four years showing name of client with duration of work/ services to be rendered.
8. OGDCL will provide transport for mobilization/ demobilization of the equipment to be serviced.
9. Prices quoted by the bidder will be inclusive of all handling charges.
10. The bidder should have active API Certificate 5CT for last 04 years.
11. The bidder is to provide, any printed technical and operational information detailing the general capabilities, services offered and any other information which would be helpful in the analysis of your company.
12. Bidder to provide the audited financial reports for the last 03 years.
13. Bidder should have valid license for cutting/ threading of premium connections. OGDCL has casing with New Vam, Vam Top, Vam 21, Tenaris TSH Blue, TSH ER, DINO VAM, Big Omega, JFE Fox/ Bear/Lion, Vam FJL, VAF integral/VA superior TSH SEC/VAGT, Vam Top

KB, TSH Wedge 513, Vam HTFNR, Vam SLJ-II & ABSTL premium connections or equivalent semi flush connections etc.

14. Any tubular/ material send to contractor's workshop will be returned to OGDCL upon completion of job with quality certificate.
15. Quantities mentioned in financial evaluation are best estimates, however the scope of work may increase or decrease as per OGDCL operational requirement.
