This Site having API Certificate No. 5L-1195 (No. 1 Equipment Manufacturing Park, Nanshugang Road, Bohai New Area, Cangzhou, Hebei, China) of "DALIPAL PIPE COMPANY" does not meet tender criteria due to following reasons. API is not authorizing for Manufacturing of Line Pipe PSL 2 - Service Annex H with delivery condition N for API 5L-1195. API 5L-1195 is not for consecutive last five years which is the requirement of tender documents.
