
All air conditioners are to be delivered at PC EFP-III base camp OGDCL near Sadqal Oil Field Fateh Jang, District Attock, Punjab.


**Mode of Procurement:**

Web tender- Single Stage One Envelope.

**Terms & Conditions:**

1. One sample of each item must be submitted by successful bidder & it shall be retained by the user department till the complete delivery of items.
2. Before delivery of each item, inspection will be carried out at the supplier/warehouse by the authorized committee of OGDCL.
3. Contractor must deposit bid money 02% of estimated cost & bid shall be valid for 90 days.
4. Delivery period is 30 days after issuance of Work Order.
5. Price quoted for each item shall be exclusive of installation charges.
6. 05% Performance guarantee of Quoted cost to be deposited by successful bidder which will be released after 06 months of supply/warranty period.
7. The contractor being registered with respective revenue authority is entitled to charge applicable sales tax over and above its bid price (excluding sales tax) and will be responsible for the payment of such sales tax to the respective revenue authority as per prevailing laws. OGDCL shall reimburse the amount of sales tax to the concerned contractor based on valid payment documents of revenue authority.
8. Payment terms as per OGDCL prevailing procedure including submission of all relevant documents for OGDCL accounts department.
9. Payment shall be released after verification of Invoice by user department.

OGDCL shall reimburse the amount of sales tax to the concerned contractor based on valid payment documents of respective revenue authority.
5. OGDCL shall withhold applicable income tax / PST / ICT as per prevailing withholding rules.
6. PST stands for Provincial Sales Tax, ICT stands for Islamabad Capital Territory Sales Tax and PKR stands for Pak Rupees.
