02. Bidder must have previous experience in supply of Blankets. Verifiable documents for already supplied similar type of material should be provided with the bid.
03. Quoted brand sample blanket, shall be provided with Bid. No bid will be accepted without sample.
04. Qualified bidder will be bound to provide material as per approved sample and brand.
05. Blankets must be of polyester (washable) and Double ply having minimum 04 Kgs weight approximately. It should be high thermal insulating blankets, single beds with size of 220*240 cm² (Approx.).
06. Each and every blanket will be thoroughly inspected at Dakhni Store, if any defect found during inspection, supplier will replace/exchange without any extra charges.
- 07. Payment will be made after 100% delivery/ inspection. Partial delivery partial payment is not allowed.**
08. Delivery period for material is **90 days** from the date of issuance of Purchase order.
09. The material will be delivered at Dakhni Gas Processing Plant Tehsil Jand District Attock, the delivery charges to Dakhni Plant to be borne by the bidder.
10. Bidder should be registered with FBR as Tax Payer and have NTN no. Bid of non-registered tax payer/ supplier/ bidder will not be entertained.
