This tender is floated for hiring of Potable water to locals of shakardara Urban & Rural (1 & 2) district Kohat for local community on daily basis on rate running contract basis. The initial term of this Contract shall be One (01) year and extendable with mutual consent. The per day requirement of the water quantities are as under.

Terms & Conditions

- 1. The contract shall be for a period of 12 months from the date specified in the contract.
- 2. POL and HSD charges will be incurred by contractor.
- 3. The contractor shall solely be responsible for any accident/incident that may occur. He shall also bear the losses.
- 4. Un- Interrupted supply of water will be made on regular / daily basis Otherwise; deduction will be made subject to quantity not provided in a month.
- 5. Bidder must provide authenticated lab reports from reputable public health laboratory.
- 6. The report shall clearly spell out whether the water is fit for drinking or not.
- 7. The bidder will be responsible for maintaining quantity /quality of water supplied to locals, Water sample lab test will be carried on random basis from reputable public health laboratory.
- 8. Quality / Quantity of water supplied will be verified by water supply control committee (WSSC).
- 9. The water supply control committee (WSCC) (this committee shall comprise of concerned AC, Chairman of concerned UC and 03 elders / notables from the concerned UC) shall monitor and control the water supply operation and will ensure that the same is transparent.
- 10. Payment shall be made on monthly basis after verification by WSCC through Cross Cheque.
- 11.Bid price shall be inclusive of all taxes, duties, levies, charges etc., except PST/ICT sales Tax on services in Pakistan.
- 12. Company reserves right to continue / terminate contract as described in Draft Contract Section # 18 "TERMINATION".

Payment shall be made on monthly basis through cross cheque in 100% Pak Rupees, against verified invoices.

(This clause will be prevailing instead of Master Tender document "ITB" clause # 07 'PAYMENT').

BID PRICE:

- i. Bid price shall be inclusive of all taxes, duties, levies, charges etc., except Provincial Sales Tax (PST)/ Islamabad Capital Territory Sales Tax (ICT) in Pakistan.
- ii. The prices should be quoted in PKR.
 (This clause will be prevailing instead of Master Tender document "ITB" clause # 06(ii) 'BID PRICE')
- **iii.** The prices quoted by the successful bidder (contractor) for required services shall remain firm and final throughout contract period. The price charged by the successful bidder (contractor) for required services shall not vary from the prices quoted by the service company.
