TERMS AND CONDITIONS

- 1. The bids shall be evaluated through "full consignment wise" bid evaluation criteria. (In order to technically qualify the bidder must quote all items with exact specifications, otherwise the bid shall be rejected).
- 2. The material shall be delivered at Nashpa Oil Field.
- 3. MTC of the material along with valid heat number must be provided.
- 4. Any required technical clarification/details regarding material to be supplied must be cleared before submission of bid. No change in submitted bid shall be entertained after bid submission date.
- 5. Material shall be accepted after final inspection at site, and payment shall be made through Cross cheque thereof.
- 6. The firm should have valid NTN and GST number and have active status on FBR website.
- 7. The Firm should have active Professional tax certificate of concerned Excise office where operating business
- 8. Tax submission Certificate (Annex-C) with submitted status be provided along with Invoice. Also IBAN of the company's account to be provided on company's letterhead duly signed and stamped for release of payment.
- 9. Management of the plant reserves the right to curtail the job list, reduce amount of items for order or terminate order at any time without any reason.
- 10. All items should be brand new. In case of counterfeit and refurbished items, the supplier shall stand disqualified from taking part in any future tender
- 11. Delivery period is 15 days after issuance of Purchase order.
