Terms and Condition for Tender

TERMS AND CONDITIONS:

1. Bids are required in PKR against each item as mentioned in the list
2. The material will be delivered at Dhok Hussain Field. The delivery charges to Dhok Hussain Field to be borne by the supplier/ bidder.
3. Any required technical clarification/detail regarding material to be supplied must be cleared before submission of bid. No change in submitted bid will be entertained after bid submission date.
4. Technical & Financial evaluation will be made on the complete scope of supply.
5. The material must be supplied within 08 weeks from the date of PO placement.
6. Certificate of Origin to be provided by vendor at the time of delivery.
7. Material will be accepted after final inspection at site, and payment will be made through Cross cheque thereof.
8. The firm should have valid NTN and GST number and have active status on FBR website.
9. The Firm should have active Professional tax certificate of concerned Excise office where operating business and same to be submitted along with the bid.
10. Tax submission Certificate (Annex-C, submitted status) should be provided along with Invoice.
11. BOE, GD or SRO to be submitted along with invoice for Income tax/GST exemption if any.
12. LD charges will be applicable as per company policy.
13. The supplier should have 10 years of prior experience of supply of Camera material.
14. Evaluation of bids will be carried out on the basis of complete list of motioned items. If any competitor misses to quote any of item, their bid will stand disqualified technically.
15. Supplier/contractor will be responsible for the provision of PPE, necessary Tools, safety and security of his crew during installation job of CCTV camera at site.
16. In case of accident during job medical treatment or compensation whichever be applicable will be the responsibility of supplier/contractor to his crewmembers.
17. Any required technical clarification /detail should be cleared before submission of bid. No change in substance of bid will be entertained after bid submission.
18. After the supply of material and completion of installation /commissioning job of CCTV Cameras at site, the supplier/contractor will submit two separate invoice for material from S.No. 01 To 24 and for services as mentioned from S.No.25 To 27 of the list. All Government Taxes will be applicable on supply of material and services as per rules.
19. Payment will be made through cross check after the supply of material at our side and successful installation and commissioning job to be verified by OGDCL Technical Team at Side.
