	Supplier's Scope				
	 A comprehensive oil testing is done before the activity to assess the health of oil. The activity will be performed online i.e. Turbine is running condition. Filtration cart will be provided by supplier (SVR1200 varnish removal skid will be engaged on oil sump as per standard operating procedures). As per oil condition report and sump size of 4200 Liters, it is estimated that total activity will take around 30-35 days which may vary as per actual conditions. During activity on-site particle count testing to monitor the progress (Minimum 06 particle counts test during whole activity). A comprehensive oil testing through third party (foreign facility) based on on-site tests and as per requirement. Onsite Testing (Particle Count) will be carried out by supplier. A final oil analysis will be done. Post Activity Advance Testing (MPC, PC, RPVOT & Ruler) will be in supplier's scope. Mob/Demob and commissioning team travel cost OGDCL's Scope Monitoring (P) and replacement of inline filters i.e. Turbine Oil Filters. OGDCL Team will assist in installation of Filtration skid. Scaffolding Services will be provided. Crane and Fork lifter services will be provided. Accommodation will be provided to field services engineers. 				

TERMS AND CONDITIONS FOR SUPPLY OF SERVICES:

- To provide HYPRO Soluble Varnish removal system (Or Equivalent) along with services to remove the deposited contamination and varnish from the Lube oil system of Gas Turbine.
- 2. Oil varnish removal involves removal of both "Soluble" and "Insoluble" Varnish and contaminants which will be accomplished through two stage varnish removal.
 - a) Stage One for Soluble Varnish removal by using Ion Exchange (ICB) technology which works on adsorption principle and removes soluble content of varnish at a molecular level.
 - b) Stage 2 for Insoluble removal by a very high efficiency glass media filtration with 0.9 micron filter of Beta 4000 which is 99.99% efficient in removing insoluble
- 3. Bid should be valid for 150 days from the date of bid opening date.
- 4. Services should be completed within 05 weeks after arrival of services team at site. Services team should be mobilize within 02 weeks from the date of issuance of purchase order.
- 5. Single stage, Single envelop bidding will take place for the bids evaluation.
- 6. Supplier/ bidder must have already provided similar services to E&P, Petrochemical and fertilizer companies of Pakistan.
- 7. The services will be delivered at Dakhni Plant, Mob/Demob of all accessories and field services engineers will be in bidder scope.
- 8. OGDCL will provide only boarding/lodging at Dakhni.
- 9. Onsite installation and Commissioning will be provided by the supplier commissioning team.
- 10. The hoses (5 meters suction and 5 meters discharge) and electrical cables (10 meters) will be inclusive in this rental skid. In case of extra hoses and cables, OGDCL can assist the supplier.
