3. Bidder/Supplier MUST be authorized distributor of OEM and provide authorization certificate along with technical bid.
4. Supplier shall submit Material Specification and Country of origin confirmation from OEM along with technical bid.
5. Material will be delivered at Uch Gas Field-OGDCL in original OEM packing.
6. Inspection of material will be carried out by the OGDCL rep. at Uch Gas Field and authenticity of supplied bearings will be verified via available Online Application(s) of OEM.
7. In case supplier fail to comply any of the above requirement the consignment may be deemed as rejected.
8. Delivery of material is to be completed in 50 days from the date of receipt of firm purchase order.
9. Bids evaluation criteria will be group wise.

**GENERAL TERMS AND CONDITIONS:**

- A. BIDS MUST BE SUBMITTED UNDER **TWO ENVELOPES BIDDING SYSTEM** i.e. TECHNICAL & FINANCIAL BID SEPARATELY ON DUE DATE.
- B. FINANCIAL BIDS OF ONLY TECHNICALLY RESPONSIVE BIDDERS WILL BE OPENED PUBLICLY.
- C. AFTER TENDER OPENING "TECHNICAL BIDS" WILL BE REVIEWED. THE BIDS WILL BE BROUGHT TECHNICALLY AT PAR BY SEEKING CLARIFICATIONS.
