Terms & Conditions:

(All bidders must confirm to abide by following Terms & Conditions)

- 1. Only the bids of independent Third Party Inspection agencies shall be entertained and bid of those bidders, which are subsidiary of the Inspection agencies / manufacturer / doing operations as supply house, shall be rejected. A certificate to this effect to be enclosed with the proposal.
- 2. Minimum overall score required for qualification is 70 Points. However, a minimum of 70% score needs to be attained in each category to qualify.
- 3. Duration of open frame work agreement shall be three (03) years from the date of issuance of notification of award.
- 3. Pre-inspection Documents
 - a. Work / Service Order
 - b. OGDCL complete contract copy
 - c. Technical specification part of the tender

4. Deliverables:

- a. All-inclusive pricing for inspections on lump sum basis (including mobilization, transport, documentation etc) for number of days mentioned in scope of work.
- b. Three CV / detailed resumes to be furnished with work/inspection portfolio for OGDCL approval with 10 years relevant experience and qualifications
- c. Onsite inspector within 72 hours (Factory site, transportation delays, or any event considered an Act of God are exceptions)
- d. Same day inspection reports (80% of all audit reports are delivered the same day). In case of chemicals or where testing is required seven (07) working days shall be allowed.
- e. Payment of inspection invoice would be made after post-shipment inspection in Pakistan by OGDCL team.
- 5. Inspector qualifications:
 - a) OSHA, ISO & relevant Professional Certifications
 - b) Experience at least 10 years in the relevant inspections
 - c) 10 years relevant experience and qualifications
- 6. Non-Conformance:

If any non-conformance is found during post-shipment Inspection in Pakistan, not pointed out / mentioned by third party inspector in its submitted report, OGDCL would not pay the inspection charges and might forfeit the PBG of inspection company (if any).

7. A Certificate to be provided with the bid on the letter head of the company stating that all enclosed documents and information provided with the bid is genuine, if at any stage these documents are found fake/forged. Then OGDCL can take any action deemed necessary i.e cancellation of pre-qualification/blacklisting etc.
