Falcon Geoconsulting was established in 2016 (as per Certificate). The technical evaluation committee sent a clarification on 14-05-24 regarding the company experience clearly mentioned in the study TOR, to which the bidder responded with an affidavit/letter head mentioning dates when the company was established. The committee again sent a clarification on 21-05-24 to the bidder to provide incorporation certificate of the company as per the dates mentioned in the affidavit/letter head, which the bidder failed to provide.
4	M/s DeGolyer and MacNaughton	Non- Responsive	Reference annex-I of the technical bid, D&M provided the list of 20 projects which were completed by D&M and SGI (10 each) in last 20 years. It was observed that at the time of bid submission, D&M solely submitted the bid as a single company and no JV agreement with SGI was submitted. Sub clause 25.3.1 of the TOR states "The JV agreement shall be signed and provided with the technical bid so as to be legal binding on all partners". In order to resolve this issue, a clarification was sent to the bidder 04/18/2024 to provide the JV agreement with SGI. In response of this clarification, the bidder submitted a MOU which seems not to be as legal binding. In the absence of JV agreement, the projects done solely by the D&M were considered towards the technical evaluation and the bidder obtain only 11 marks which resulted in the disqualification from the bidding process.
